From the above by-passing system he/she uses the following electrical equipments.

Air Conditioner - 02 nos, Electric Fan - 05 nos  
Tube light - 04 nos, Edam TV - 02 nos, Computer - 01 no.

Out of which I seized the following.

Pvc 2 core service connection cable for bypass arrangement along with a change-over switch - 5 mtr (approx)

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 2.40 PM on 08/8/2017. The accused person has committed an offence U/S135(I) (b) of the electricity act.-2003 subsequently electricity (Amendment) act.- 2007.
