To, The Officer -In -Charge, Purulia Town PS Dist: Purulia

I the undersigned would like to inform you that on 2/08/2017 at about 11:30pm Respected Sir, while I was at hospital more, Manbhum medical buying medicine at that time one Tushar Awasthi, S/o Kripa Shankar Awasthi a resident of Chabi biri bagan by lane, Dhuniya Moholla, old Police line, PO + PS and Dist: Purulia, suddenly became aggressive and attacked to assault me by fist and blows. He had been previously also using abusive language and words to insult me for being a Scheduled Cast. He insulted me saying that since I belonged from a lower cast so I should only work to clean latrines. He insulted my parents and used abusive words against my parents. He assaulted me purposely and when my other friends protested, he snatched my silver chain which I was wearing and fled away. Later i came to learn that he got admitted in Deben Mahato Sadar Hospital, Purulia and there from he arranged to make referral and admitted in Bokaro Hopspital. On the next day brother and mother of Tushar Awasthi namely i) Siddhant Awasthi and ii) Nidhi Awasthi came to my house at about 11:30 am. They demanded a sum of Rs 30,000 so that the undersigned would not be implicated in a false case which is punishable with imprisonment for life and threatened me, for fear of that seeing no alternative I had to pay a sum of Rs 5000 under compulsion and both of them fled away. On the same day they lodged a false complaint against me for which I was arrested on 3/08/2017 and after obtaining bail I was released on bail on 23/08/2017. While I was in the jail custody Tushar Awasthi came to visit me on 11/08/2017 he threatened me to not to do any counter case against him, if doing so he threatened to frame in other false allegation like attempt of rape or any other case and also demanded the balance Rs 25,000 for withdrawing the case against me.

For under the circumstances, setforth it is crystal clear that the above named three persons are hatching a criminal conspiracy, committed various offences of threat, racist comments against my cast, extortion, attempt to commit murder, etc, which are punishable according to law.

You are requested to take legal action against them.
