



The humble petition on behalf of the petitioner above-named; Most respectfully begs to state:

- That the petitioner is legally married wife of the accused person Jaideep Sahis, having their marriage solemnized according to Hindu Rites and customs prevailing in their society about 12 years back in the month of August 06,2005, is still subsisting between them.
- 2. That the marriage was solemnized through negotiation with the accused person Jaideep Sahis at S.D.Hospital , Salka , Raghunathpur , P.O.-Raghunathpur , P.S.-Raghunathpur , Dist.-Purulia ,W.B.
- 3. That at the time of their marriage, the accused person Jaideep Sahis and his family member demanded cash and gold ornaments, furniture, utensils from the father of the petitioner.
- 4. That as per demand of the accused person Jaideep Sahis, the father of the petitioner was forced to pay of rupees 20,000/- (twenty thousand only) in cash, with 2 bhori gold ornaments, Vehicle amount of Rs. 20000/- (twenty thousand only) and other valuable articles amount of Rs.5,000 (aprx.).
- 5. That after solemnized of marriage the petitioner had been to her matrimonial home at S.D.Hospital , Salka ,Raghunathpur , P.O.-Raghunathpur , P.S.-Raghunathpur , Dist.-Purulia ,W.B. with all the dowry



- 6. That after marriage, the petitioner in her matrimonial home initially she was behaved well by the accused person Jaideep Sahis and the family members of accused persons. But after few months the behavior of her husband and other family members of her mother- in-laws change a lot and both the accused person started to ill treatment upon the petitioner both mentally and physically without any reasons, she was deprived from proper food, clothing, and the daily necessities. They had even hidden and torn the saree/ wearing apparels of the petitioner, thus in many ways the petitioner was harassed and caused cruelty by the accused person Jaideep Sahis and his other in-mates.
- 7. That the petitioner became mother and produce a female child at Sadar Hospital, Purulia, dated on 20/05/2006 without any help from the accused person. It is noted that all the hospital expenses carried by father of petitioner at that time.
- 8. That the accused person Jaideep Sahis and his other mother suddenly demanded further dwory amount of Rs. 50,000.
- 9. That the petitioner has swallow all such metal pain with hope that with the passes time the accused person Jaideep Sahis will change himself and happy days will come again but all hopes of the petitioner was in vain.
- 10. That having no alternatives the petitioner informed the matter in her parental house.
- 11. That the petitioner is a devoted wife and considering the dignity of both the families and with a hope that a sense will prevail upon the accused person Jaideep Sahis in future, but ultimately on April ,2017 the accused person Jaideep Sahis and mother-in-laws drove her out from her matrimonial home after physically assaulting her.
- 12. That the petitioner complained against the accused persons to the Raghunathpur Mahila Thana April, 2017 but Thana did not take any action against the accused persons and at that time Raghunathpur Mahila Thana advised to petitioner to solve the family problem go to the Family Counseling Centre which is run by Central Social Welfare Board.
- 13. That the father of the petitioner, made several attempt to resolve the matter amicably, but the accused person Jaideep Sahis did not pay any heed.



- 14. That the petitioner having no other alternative took shelter of her father's house at Reny Road , Dhobghata , Word No-16 , P.O.- Namopara , P.S.-Purulia (Town) , Dist.-Purulia , W.B. Pin-723103 .
- 15. That dated on 25th June ,2017 the accused person Jaideep Sahis came to the petitioner father's house and massive physically assaulting to the petitioner with his hands , legs and helmet in front of Sibani Sahis who is sister of the petitioner . At that time Sibani Sahis was trying to rescued to the petitioner . But the accused person Jaideep Sahis also assaulting to the Sibani Sahis . ,
- 16. That on 26/06/2017, the petitioner had reported the matter to the O.C., Purulia(Town) but the O.C. Purulia(Town) p.s. did not gave any received copy to the petitioner and O.C. Purulia(Town) p.s. referred to the petitioner to the Mahila Thana O.C. Purulia(Town)p.s. and the petitioner visited to the Mahila Thana but the Mahila Thana did not took any action against the accused persons and finally on 6/07/2017, the petitioner had reported the matter to The S.P., Purulia but till date no action was taken.
- 17. That there is clear the petitioner husband and her mother-in-laws of the petitioner subjecting her to cruelty, assaults, mental and physically tortured and which offences punishable u/s-498(A),323 of Indian Penal Code.

It is, therefore, prayed that your Honour may graciously be pleased to direct the police of Purulia(Town) police station to treat this petition of complaint as F.I.R. and to cause investigation in respect of the alleged incident in provisions of u/s 156(3) Cr.P.C.

And for which act of kindness your petitioner as in duty bound shall ever pray.
