with due respect I would like to inform
you that yesterday i.e. on 2/08/17 at about 11:50 PM

I got a phone call from Siyam Sundar Sharma
that my brother Jishu Awasthi is admitted at
Sadar Hospital at that time as he was
injured by one of his friend ~~name~~ named
Babla Soni, S/o Hemlal Soni, resident of
Station para, Dakbangla, P.O + P.S. + Dist - Purulia.

I along with my parents and family rushed
to the hospital and found my brother admitted
in the hospital in a senseless state, as he
successfully sustained fatal injury on the back
side of his head. Then I enquired regarding
the injuries to the doctor. The doctor
referred my brother to Bokaro as we
took him to Bokaro general hospital for
a better diagnosis for the injuries sustained
in the assault.

After that from S.K. Sonny,
a friend of my brother, I came to know
about the incident, that they were standing
and gossiping outside the Sadar hospital.
At All of a sudden, a normal conversation

was transformed into a heated argument between my brother and Babla Dom, who on losing his temper started assaulting my brother too and few without a specific cause on different parts of my brother's body. People around there, did their best to stop Babla Dom but then all of a sudden Babla Dom with high grace and with intention of gravely injuring my brother picked up a stone and banged at my brother's backside of the neck, my brother fell to the ground following this, he was senseless and despite knowing this he kept on hitting him on his chest and stomach with his leg which inflicted several injuries on my brother's body. He didn't even stop, he fled from there immediately. Had it not been for the crowd the scene Babla Dom could have killed my brother Tushar Awasthi. As my brother had to be admitted to Bokaro and other demand for his treatment I could not give the information to you until now.

Please take necessary action against Babla Dom, so that his desperation of hurting others badly without fear of law and order is checked and help my brother to get justice.

We hope necessary aid will be provided to
CED.
