That the said document bears fake Notarial Seal of Aditya Banerjee Notary. That the serial no. and date appearing on the said document are false. This is a clear instance of forgery with the purpose of cheating innocent people at large and it requires prompt action to nab the racket behind the unlawful game.

Hope you would treat this complaint as F.I.R. and initiate appropriate investigation.
