During inspection theft of electricity was detected i.e he was using electricity dishonestly by means of direct hooking from LTOH line of WBSEDCL.

From the above arrangement was seized 1 Pvc cable ~~of~~ approx length - 15ft. 2) Sub's wire holder - 01 No.

Seizure list was prepared at site, representative of the accused person refused to sign.
