In producing herewith 1)One Dumper having Registration no- JH04D/4115 loaded with 08(Eight) M.T.(approx) coal, 2) 06(Six) M.T.(approx) seized coal from the P.O. 3) One Original Loading advice cum Road Challan of Bharat Coking Coal Limited ,4) one Original Weighment Slip of Bharat Coking Coal Ltd, 5) One Original Transport Challan, 6) One Original Challan of NKAS Services PVT. LTD. all under seizure under proper seizure list duly signed by witnesses, I do hereby lodged a compliant against 1) Debdas @ Makar Tewary S/O- Lt. Haradhan Tewary of Ausurbandh, PS- Santaldih, dist- Purulia, 2) Owner, Driver and Helper of Vehicle no- JH04D/4115, Transport Authority and others to the effect that Today(16/8/17) at 01.15 hrs during my Night mobile duty, I received a source information that the driver, helper of the vehicle no- JH04D/4115 entered into the premises surrounded by boundary wall at Paharigora, PS- Santaldih, occupied and possessed by Debdas @ Makar Tewary and with the help of Debdas @ Makar Tewary, the driver and helper of the said vehicle started unloading the said coal with a view to replacing the original coal of the said vehicle with another coal of cheap and lower quality supplied by Debdas @ Makar Tewary. I informed the matter to I/C Santaldih PS over telephone and as per order of I/C Sanaldih PS, myself along with C/704 Kamal Punuria, C/546 Nakul Das reached there at 01.35 hrs and noticed 5/6 persons were standing near the said vehicle and unloading the coal from the said vehicle. Seeing the police personnel, they fled away. But of them I could be able to identify one Makar @ Debdas Tewary with the help of focus of a torch light. On search, it was found that the said vehicle contains coal approx 08M.T. and 06M.T.Coal on the ground which was unloaded from the said vehicle. I searched the cabin of the said vehicle and found some papers relating to the coal which I seized from the spot. On local enquiry, it came to light that the said coal loaded on the said vehicle was to be dispatched to the authority of the R.T.P.S, Raghunathpur, and on the way, the driver, helper of the said vehicle and Debdas @ Makar Tewary replace the original coal with another coal lower and cheap quality habitually and in this way, they have been running such illegal coal business in collusion with the owner of the said vehicle, Transport Authority and others.

Therefore, I pray to you that a specific case may kindly be initiated against the above noted accused persons as they have committed offence U/S- 379/411/413/414/407/120B IPC. .
