The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) Electric Fan - 2 Nos., 2) Elec. Bulb - 02, 3) Heater - 01
- 4) water Pump - 01 No.

Out of which I seized the following.

- 1) Heater along with connecting wire and Plug - 01 No.
- 2) Pvc. 2 core Cable for bypass arrangement - 08 ft (approx)
