and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing  
the energy meter i.e. U/S135(I) (b) was detected. The details of passing the arrangement was damage  
installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his  
house without energy registration in WBSDFCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) Electric Fan - 2 Nos.
- 2) Elec. Bulb - 02
- 3) Heater - 01
- 4) water pump - 01 No.

Out of which I seized the following.

- 1) Heater A long 2 wire connecting wire and Plug - 01 No
- 2) PVC 2 wire cable for bypass arrangement - 08 ft (approx)

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left  
the premises at 04.47 P.M. on 07/08/2017. The accused person has committed an offence  
U/S135(I) (b) of the electricity act.-2003 subsequently electricity (Amendment) act.- 2007.
