I beg to report that on 23.09.2017 at 11.05 hrs. O/C Adra PS received a secret information that one gambling with huge amount was going on at Office of S E Railway Men's Union Branch-II near Bengali Samity, Adra under Adra PS. The matter was diaries vide Adra PS G D E No. 949 Dtd - 23 09:2017 accordingly as per order of O/C Adra PS I S I Supratik Mondal along with ASI Habibul Rahaman Mondal (1) C/464 Purna Chakraborty (2) JC/862 Ujjal Rajak (3) JC/411 Pinku Saha (4) JC/1236 Ranjit Nayek left for Office of S E Railway Men's Union Branch-II, Near Bengah Samity Adra to work out the information. At about 23.55 hrs. we reached near Bengali Samity and very slowly and cautiously approached towards the hall room of the said office where the gambling was reportedly going on. Within a few moment it was clear that the persons present there were continuing gaming with playing cards in exchange of money causing wrongful loss to one and wrongful gain to another. After that I asked my associate staffs to cordon the place and within a moment the place was cordoned by Police party. After that we asked their identity and the persons disclosed their name and address as noted above. It was found that a huge amount of currency note of different denomination were kept on gaming board (One yellow coloured blanket placed on the floor) and playing card were also found. On demand the persons clearly confessed that all of them were doing gambling with playing cards in exchange of cash for wrongful less to one and wrongful gain to another. We searched for the public witnesses but none was available. After that in presence of persons noted above the board money of Rs 19,200 (Nineteen Thousand Two Hundred Rupees only) with different denomination, 175 nos of Playing cards, One yellow coloured blanket and. One Green coloured exercise book in which all accounts of transaction during this gubmling in being maintained were seized for the gaming board in between 00 10 hrs. to 00.45 hrs. (24.09.2017) under proper seizure list.

As such for committing offence punishable U/S 3 & 4 of WBG & P.C. Act all the above noted 8 (Eight) persons were arrested, issuing arrest memo between 00:46 hrs. to 01:05 hrs. (24:09:2017).

From the statement of accused persons it was clear that the gaming was going on under guidance and full of knowledge of the care-taker of the said office namely Bablu Khan (42 Yrs.) S/O Lt. Abdul Hussain of Lower Benjasole. Adra PS- Adra Dist-Purulia

Therefore I pray before you that one specific case may kindly be start under proper section of law against the above noted accused persons and arrange its investigation.
