Sir,

In producing herewith the arrested accused persons namely (1) Md. Salim (51 Yrs.) S/O Lt. Siddique of Lower Beniasole, Adra PS- Adra Dist- Purulia (2) Premchand (45 Yrs.) S/O Lt. Ramnath Yadav of Rly. Qtr T 42/C 709 Choto Hospital PS- Adra Dist- Purulia (3) Devendar Bhouthkar (25 Yrs.) S/O Gopal Bhouthkar of Arobindopally Near Masjid Para, Adra PS- Adra Dist- Purulia (4) Bablu Khan (42 Yrs.) S/O Lt. Abdul Hussain of Lower Beniasole, Adra PS- Adra Dist- Purulia (5) Prabhu Shaw (42 Yrs.) S/O Lt. Mahadeb Shaw of Vill- Panchudanga PS- Adra Dist- Purulia (6) Makesh Prasad (36 Yrs.) S/O Samim Sheikh of Upper Beniasole PS- Adra Dist- Purulia before you, along with seized articles like board money amounting to RS- 19,200/- and 175 nos of playing cards, etc. as per seizure list.

I beg to report that on 23.09.2017 at 11:05 hrs. O/C Adra PS received a secret information that one gambling with huge amount was going on at Office of S E Railway Men's Union Branch-II near Bengali Samity, Adra under Adra PS. The matter was diaries vide Adra PS G.D.E No- 949 Dtd- 23.09.2017 accordingly as per order of O/C Adra PS I S I Supratik Mondal along with ASI Habsul Rahman Mondal (1) C/464 Purna Chakraborty (2) JC/862 Ujjal Rajak (3) JC/411 Pinku Saha (4) JC/1236 Ranjit Nayek left for Office of S E Railway Men's Union Branch-II, Near Bengali Samity Adra to work out the information. At about 23.55 hrs. we reached near Bengali Samity and very slowly and cautiously approached towards the hall room of the said office where the gambling was reportedly going on. Within a few moment it was clear that the persons present there were continuing gaming with playing cards in exchange of money causing wrongful loss to one and wrongful gain to another. After that I asked my associate staffs to cordon the place and within a moment the place was cordoned by Police party. After that we asked their identity and the persons disclosed their name and address as noted above. It was found that a huge amount of currency note of different denomination were kept on gaming board (One yellow coloured blanket placed on the floor) and playing card were also found. On demand the persons clearly confessed that all of them were doing gambling with playing cards in exchange of cash for wrongful loss to one and wrongful gain to another. We searched for the public witnesses but none was available. After that in presence of persons noted above the board money of Rs 19,200 (Nineteen Thousand Two Hundred Rupees only) with different denomination, 175 nos of Playing cards, One yellow coloured blanket and One Green coloured exercise book in which all accounts of transaction during this gambling in being maintained were seized for the gaming board in between 00:10 hrs. to 00:45 hrs. (24.09.2017) under proper seizure list.

As such for committing offence punishable U/S 3 & 4 of W.B.G & P.C Act all the above noted 8 (Eight) persons were arrested, issuing arrest memo between 00:46 hrs. to 01:05 hrs. (24.09.2017).

From the statement of accused persons it was clear that the gaming was going on under guidance and full of knowledge of the care-taker of the said office namely Bablu Khan (42 Yrs.) S/O Lt. Abdul Hussain of Lower Beniasole, Adra PS- Adra Dist- Purulia.

Therefore I pray before you that one specific case may kindly be start under proper section of law against the above noted accused persons and arrange its investigation.
