In producing here with one arrested accd. namely Maheswar Karmakar @ Madha (35 Yrs) S/O Tarapada Karmakar of Rly. Qtr. DS 9/11, DS Colony, Adra PS- Adra Dist- Purulia along with following seized articles viz-

- 1) 20 bottles (in sealed condition) DIL KHUSH 80 up country spirit, 600-ml each bottle and value-Rs-30 of each bottle.
- 2) Sale proceed of Rs.-75/-
- 3) Ten pieces of plastic glass.

I ASI Giridhari Roy of Adra P.S. do here by lodged a complaint against accd. Maheswar Karmakar @ Madha (35 Yrs) S/O Tarapada Karmakar of Rly. Qtr. DS 9/11, DS Colony, Adra PS- Adra Dist- Purulia to the effect that on 26.09.17 at about 18:05 hrs in course of my anti crime evening mobile duty I received a telephonic information from a reliable source that one Maheswar Karmakar @ Madha (35 Yrs) S/O Tarapada Karmakar of Rly. Qtr. DS 9/11, DS Colony, Adra PS- Adra Dist- Purulia was stocked country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Adra PS and as per order of O/C Adra PS myself along with JC/411 Pinku Saha & JC/340 Aswini Mondal rushed to the spot for raid by Govt. vehicle. At about 18:45 hrs. myself along with force reached at Gayadih, Adra and hold raid in the Jhupri at Gayadih of Maheswar Karmakar @ Madha found that said Maheswar Karmakar @ Madha liquor at his own Jhupri and seeing the Police party some person fled away and said Maheswar Karmakar @ Madha to concealed himself but we are able to apprehend him and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produced any valid license or documents for possessing /selling the same, So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accd. person and available witnesses.


