I SI SK Ismail Ali, O/C Baghmundi P.S do here by lodge Suo-Muttu complaint against arrested accused persons namely 1. Sahid Momin S/O Samser Momin of Vill- Hurumda, P.S-Baghmundi PS, Dist- Purulia, 2. Sultan Momin S/O Mantu Momin of Vill- Hurumda, PS- Baghmundi, Dist-Purulia along with 100/150 others to the effect that on 04.09.2017 at about 11.50 hrs received information from Birgram Village that a minor girl of Jiling, PS- Baghmundi, had been kidnapped by Three (03) Boys on Motor Cycles. While passing through Birgram village with the kidnapped girl two of the three boys had been detained by an agitated mob at Birgram. This refers Baghmundi GDE no 163 Dated 4/9/17. After having heard this information I being Officer -In Charge of Baghmundi P.S. diarized the matter and having informed superiors, left the P.S. for Birgram Village immediately along with Officers & Force namely 1. SI Sourav Bannerjee 2.C/771 monohar Pathak 3. C/773 Sudarshan Majhi by Govt. Vehicle vide C.C. No 3371 Dated- 04.09.2017 and GDE no 166 Dated 4/9/17. On way to Birgram one person who disclosed his identify as Ajit Mahato of Jilling stopped our vehicle at Charida More, PS-Baghmundi and reported that his minor daughter Rukmoni Mahato (17Yrs) had been kidnapped by three (03) miscreants namely 1. Nazim Ansary of Vill- Jiling, PS-Baghmundi, Dist-Purulia and 2.Sahid Momin 3. Sultan Momin both of Vill-Hurumda, PS- Baghmundi, Dist-Purulia, on 4/9/17 at about 11.00 hrs in front of Birgram High School. We reached at Birgram Village at about 13.25 hrs and found that an agitated mob of almost 100/150 unknown persons had kept one Sahid Momin S/O Samser Momin, and Sultan Momin S/O Mantu Momin both of Vill-Hurumda, PS- Baghmundi, Dist-Purulia detained. In order to rescue to detainees, I asked the members of the mob to disperse, but the mob did not pay any heed. As such I declared the mob as unlawful assembly and warned to apply force, if not disperse immediately. The warning worked and the mob dispersed. We rescued the two detainees and interrogated them on the spot. They informed that they along with one Nazim Ansary of Jilling, PS- Baghmundi, Dist-Purulia were taking away one Rukmoni Mahato, aged about 16/17 years D/O Ajit Mahato of Vill- Jiling, PS-Baghmundi, Dist-Purulia, with whom Nazim Ansary was having an affair, from the vicinity of Birgram High School on 4/9/17 at about 11:00 hrs on Motor Cycles. On their way, at Birgram one Motor Cycle broke down due to mechanical fault. Some people then chased them and detained two of them while Nazim Ansary managed to escape with the kidnapped girl. After being detained, 100/150 people encircled them and manhandled and assaulted them, as a result of which they sustained bodily injuries. Considering the information of Ajit Mahato, father of kidnapped girl and the confession of these two detainees I arrested 1.Sahid Momin S/O Samser both of Vill- Hurumda, PS-Momin, 2. Sultan Momin S/O Mantu Momin Baghmundi, Dist-Purulia for having complicity in kidnapping of minor girl maintaining all formalities according to law and also seized a Motor Cycle (Hero Glamour black coloured) bearing reg no-JH05 BN 6866, 05 Lathis, in a proper Start & Broper of the tensed situation at Birgram, I awaited for reinforcement to arrived at the P.O. in order to ensure smooth and safe retreat with the two arrested accused persons.

PS Care no. 108 PAfter arrival of reinforcements from different Police units I left the P.O. and from the Atd-4 19117 P.O. I went to Pathardih B.P.H.C. and get the two arrested accused. there and returned to P.S. with arrested accused persons and seized articles.

As such the persons 1.Nazim Ansary S/O not known of Vill-Jiling, PS- Baghmundi, Dist-Purulia and 2.Sahid Momin S/O Samser Momin of Vill-Hurumda, P.S-Baghmundi PS, Dist- Purulia, 3. Sultan Momin S/O Mantu Momin of Vill- Hurumda, PS- Baghmundi, Dist-Purulia and 100/150 unknown others committed an offence punishable U/S- 363/365/120B/341/147/149/323/506 IPC and on my return to PS and started Baghmundi PS case no- 108/17 Dtd-04/09/17, U/S- 363/365/120B/341/147/149/323/506 IPC as Suo-Mottu and

Officer-in-charge endorsed SI Kousik Banerjee ,Incharge- Suisa OP under Baghmundi P.S. to BAGHMUNDI P. investigate the case.
