Sub: Complaint against Arjun Saw (48 yrs) S/O- Lt. Chuman Saw of Vill.- Diputard, P.S.- Balarampur, Dist. Purulia to start a cog case U/S 46A(C)B.E. Act.

Respected Sir,

In producing here with one arrested accused person namely Arjun Saw (48 yrs) S/O- Lt. Chuman Saw of Vill.- Diputard, P.S.- Balarampur, Dist. Purulia along with seized 25 (twenty five) sealed country sprit bottles (DIL KHUS) (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 18:15 hrs I received a credible source information that one person namely Arjun Saw, S/O- Lt. Chuman Saw of Vill.- Diputard, P.S.- Balarampur, Dist. Purulia is selling country sprit without any valid license from his own house at village Diputard under Balarampur P.S., Dist.-Purulia. Accordingly, I along with force left for village Diputard to work out the source information and held raid in the house of accused person.

During search with the help of accompany force, we found that the said person is selling country sprit bottles at his own house. On demand, he failed to produce any valid documents/ License in respect of selling and keeping of said country sprit. Accordingly, I seized all the sealed country sprit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labeled sample bottles. Total 15 (fifteen) liters country sprit has been seized, total value of the said seized sprit is Rs- 875/= (eight hundred seventy five only) and arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C)B.E. Act against the arrested accused person namely Arjun Saw, S/O- Lt. Chuman Saw of Vill.- Diputard, P.S.- Balarampur, Dist. Purulia and arrange for its investigation.
