I Sri Amitava Choudhury, S/O- Lt. Sajal Kr. Choudhury, A.E & Station Manager of Balarampur CCC of WBSEDCL do hereby lodge complaint against Aklu Sahis, S/o. Lt. Sudhu Sahis resides at Vill - Serenghatu, Po. Ghatbera, PS: Balarampur, Dist. Purulia to the effect that received an information that the aforesaid accused person is committing theft of Electricity in his residence by way of direct hooking from the LTOH Line of

Acting upon such information today on 01.09.2017 from 12.25 PM to 12.35 PM I, along with Sri Samar Kumar Pandey, (Retd. D.S.P), S.O. (S&LP), Purulia Region Office, Sri Anup Mandal, S.A.E , Sri Arindam Chatterjee, O.E Balarampur CCC and technical persons of M/s. Ajoy Kr. Ghosh (Enlisted Agency of WBSEDCL) inspected the premises of Aklu Sahis and held raid.

During raid and inspection it was detected that accused Aklu Sahis is using electricity dishonestly by making direct hooking from the nearby LTOH Line of WBSEDCL for running 1Nos. 60 Watt Lamp & ,1 No. 40 Watt Lamp having connected load 0.10 KW. There exists one BPL Service Connection of WBSEDCL stands recorded in the name of the Accused which was in disconnected condition.

I prepared Inspection report in presence of the representative of the Accused and assessed the Load as 0.100 Kw. Details have been mentioned in the Inspection Report and duly signed by the Accused.

I directed the technical persons of M/s. Ajoy Kr. Ghosh (Enlisted Agency of WBSEDCL) to disconnect the hooking line from our LTOH line. Accordingly they disconnected the aforesaid the aforesaid hooking line

I prepared seizure list in presence of witnesses, details of seizure have been mentioned in the seizure list and obtained the signature of the accused. A copy of the seizure list was handed over tof the accused. The Local people gathered there witnessed the incident but refused to sign on the Seizure list and inspection

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offence u/s 135(i)(a) of Electricity Act 2003 (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the accused.
