Sub: Lodging F.I.R against Sadhu Singh Sardar, S/o. Lt. Ruthu Singh Sardar for unauthorized use of Electricity by way of hooking u/s 135(i)(a) of Electricity Act 2003 (Amended in 2007).

Sir,

I Sri Amitava Choudhury, S/O- Lt. Sajal Kr. Choudhury, A.E & Station Manager of Balarampur CCC of WBSEDCL do hereby lodge complaint against Sadhu Singh Sardar, S/o. Lt. Ruthu Singh Sardar resides at Vill - Bandhdih, PS : Balarampur, Dist. Purulia to the effect that received an information that the aforesaid accused person is committing theft of Electricity in his cultivating land by way of direct hooking from the LTOH Line of WBSEDCL.

Acting upon such information today on 01.09.2017 from 2.55 PM to 3.35 PM I, along with Sri Samar Kumar Pandey, (Retd. D.S.P), S.O. (S&LP), Purulia Region Office, Sri Anup Mandal, S.A.E , Sri Arindam Chatterjee, O.E Balarampur CCC and technical persons of M/s. Ajoy Kr. Ghosh (Enlisted Agency of WBSEDCL) inspected the premises of Sadhu Singh Sardar and held raid.

During raid and inspection it was detected that accused Sadhu Singh Sardar is using electricity dishonestly by making direct hooking from the nearby LTOH Line of WBSEDCL for running 1No. Monoblock Pump Set having connected load 1 HP / 0.75 KW for watering his cultivating land.

I directed the technical persons of M/s. Ajoy Kr. Ghosh (Enlisted Agency of WBSEDCL) to disconnect the hooking line from our LTOH line. Accordingly they disconnected the aforesaid the aforesaid hooking line from LTOH Line.

I prepared seizure list in presence of witnesses, details of seizure have been mentioned in the seizure list and the representative of the accused present refused to sign on the seizure list. A copy of the seizure list was handed over to the representative of the accused. The Local people gathered there witnessed the incident but refused to sign on the Seizure list.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offence u/s 135(i)(a) of Electricity Act 2003 (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the accused.
