I would like to inform you that one life convict no. **5405/A,JID- 6-740-2007-CT** namely Nibaran@Sahebram Murmu(Age-37 years) s/o Shishulal Murmu of Village Bangara, P.S-Bandowan, Dist-Purulia who was detained at this Correctional Home in connection with S.T. No. 02/07 SC No. 420/06 u/s-302/326 IPC was proceeded on 07 (seven) days short leave parole w.e.f 14.09.2017 to 22.09.2017 excluding journey time furnishing two sureties bond of Rs 500/- each, as per existing rules, in the name of 1) Sri Baneswar Majhi S/O Thakur Majhi of Village- Purano Burudi, Goalikocha, PS-Arsha, Dist- Purulia and 2).Saral Majhi @ Hembram S/O Gonsai of Village-Tilaitand, P.S-Arsha, Dist-Purulia (Under intimation to his PS vide this office Memo No. 7329/RB dated. 14.09.17). His date of return is fixed on 22.09.2017. But the said convict didn't return to this Correctional Home on the schedule time after availing the same.
