entered the premises of Paban Das Mahanta, s/o - Bharat Das Mahanta at Supudi and inspected his premises. During inspection his brother Bidyut Das Mahanta along with local villagers were present there and in front of them theft of electricity was detected U/s 135(1).

After detection of theft of electricity his brother (Bidyut Das Mahanta) fled away but local villagers were present. The seizure list was prepared at the site but local villagers and their representatives refused to sign on the seizure list.

The unauthorized service line was disconnected immediately.

From the above arrangement he was using following electrical equipments:-

- i) Electric Cooler - 01 NOS
- ii) Electric Fan - 02 NOS
- iii) Colour TV - 01 NO
- iv) CFL - 04 NOS.

out of which 9 seized the following:-

- i) Pvc 2 core cable with hook arrangement along with one 5 pin socket - (5ft) (Approved)

The inspection team left the premises at about 1-52 pm on 13/9/17. The accused person has committed an offence U/s 135(1) of Electricity ACT - 2003 & subsequently Electricity (Amendment) Act - 2007

You are requested to take cognizance of the complaint and treat it as FIR and action may be taken as per rule.
