1.---That the above named complainant is the resident of village Puijanga, P.S.Barabazar, Dist.Purulia

2.---That on 14-07-2017 at about 5 0' clock the above named complainant went to the office of Block Development Offic Barabazar, Dist. Purulia regarding his land dispute matter. When the complainant and present witnesses were taking with B.D.O.Barabazar, suddenly accuse No.1 and 2 appeared there and seeing complainant accused No.1 and 2 started abuse the complainant with filthy languages and threatened to kill the complainant in presence of B. D.O. Barabazar. B.D.O. Barabazar requested them not to use slang languages , but they do not hear the request of B.D.O. There after the accused persons drove the complainant by putting their hands on the neck of the complainant and they also threatened to cause murder. Witnesses also come out from the B.D.O. Office, but the accused No.1 and 2 followed the complainant and wrongfully restrain the complainant and started assault the complainant by fists and blows and torned the shirts of the complainant and threatened to kill the complainant. At the time many persons were gathered . Seeing the gethering of the local people accused persons No.1 and 2 were fled away from the place of occurrence.
