
The above name complainant begs to state as follows:

- That the complainant and the accused persons are the permanent resident of village- Raghunathpur, P.S. Boro,
 Dist- Purulia and within the jurisdiction of this Ld. Court.
- That on the date of occasion dated 29/07/2017 at about 2) 9:15 P.M. while the complainant party were in their house the female fockes of the family were preparing food while the male members were gossiping in the verandah of their house. At that time the accused persons without any provocation armed with various weapons like lathi, Iron rod. Farsha etc., forming an unlawful assembly criminally trespassed in the house of the complainant by breaking the door in a very riotous mood and they started to abuse the complainant and her family members in filthy languages. The male members of the family asked the accused persons for their such behavior, and there was some hot altercation, the accused persons also said that unless they be allowed to possess the disputed land they will finish all the members of the complainant so that they would be compelled to leave the village.





- 3) That the complainant and her family members asked them to quit from their house contrary to that they would call the neighboring people. In course of such altercation the accused persons indiscriminately started to assault all the family members of the complainant and that they tried to assault the Madan Singh upon his head so that the said Madan would die. But Madan Singh such tried to resists the blow of the iron rod by his right hand but fatal blow caused fracture on his right wrist/ hand. The accused persons also with the same intention assaulted said Smt. Manjura Singh on her head causing bleeding injuries at the time of incident all the accuses persons declared that the4y would murdered all the members of the family of the complainant and they will criminal intention trespassed in to the house of the complainant, but by the grace of god their life were saved.
- 4) That on the next morning the complainant and her family including injured visited to the officer-in-charge Boro P.S. when the Police asked them to make arrangement for treatment of the injuries and also assaulted them that they would take necessary against the accused persons.
- 5) That on the following day the injuries persons along with other persons and his family members of the complainant visited to the Police of Manbazar P.S. When the said





Madhu Singh, Falari Singh and Ajit Singh were detained at P.S., they also their utter surprise show that the some of the accused persons were still in chamber of the Officer-in-charge of Manbazar P.S. and on the next day those persons were forwarded before the Ld. Civil Judge Jr. division, Purulia. The said injuries Madhu Singh thereafter treated in jail Hospital as well as Purulia Sadar Hospital.

That the complainant party became very much prejudiced with the activities of the Police personnel and as the Police of Manbazar did not take any legal action against the accused persons for that the complainant lodged a complaint to the Superintendent of Police, Purulia but same fate and no legal action yet been taken against the accused person for that the complainant is compelled to file this complaint before the Ld. Court for recourse of law.

In the circumstances it is therefore, prayed that your honour may be pleased to send the petition of complaint to the Officer-in-charge, Boro P.S. treating the same as FIR under section 156(3) for investigation.
