Most Respectfully Sheweth :-

1. That, your complainant is the legally married wife of the ~~xxx~~ Accused No.1, Hiralal Pal alias Kumbhakar of Baragram- Manguria, p.s. Hura, Dist. Purulia and their marriage was performed at Ichhar P.S. Santaldih, District Purulia as per Hindu law and customs on 29th Jaiatha, 1423 B.S.
2. That, after marriage both the persons began to reside at Baragram-Manguria, P.S. Hura, Dist. Purulia.
3. That, it may be mentioned that at the time of marriage the father of the complainant was compelled to give Rs. 70,000/- cash as dowry money and other articles like utensils, palanka etc. and golden ornaments. but since after marriage all the accused persons, namely, - (1) Hiralal

Pal, (2) Jayanti Pal, (3) Ananda Pal, (4) Chitta Pal and (5) Santi Pal started pressure upon the complainant and her father to give ~~one~~ one Motor-cycle and a cash of Rs.20,000/- more but the complainant and her father expressed their inability to fulfil that absurd and illegal demand of the accused person then all sorts of physical as well as mental torture was started upon the complainant they stopped food and clothing in the meantime your complainant became pregnant. The torture by all the accused persons as mentioned above increased day by day.

4. That, on 25.12.16, all the accused persons assaulted your complainant ~~mercilessly~~ mercilessly and at the dead hours of night the husband of your complainant with the intention to kill her and the baby of the womb kicked in the abdomen/belly of your complainant as a result of which your complainant fell down became senseless and there was profuse bleeding from the internal organ caused miscarriage then without any alternative the husband of your complainant to cover up and screen the offence got your complainant admitted in ~~Shakti~~ Chakaltore Hospital but the Hospital referred her -

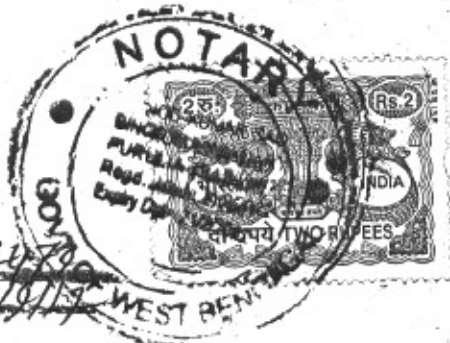

her in the Purulia Sadar Hospital thereafter the husband fled away from Purulia Hospital leaving behind the complainant saw the dead child.

That, on 27-12-16, getting information the father of your complainant came and ^{took} ~~took~~ your complainant to his house at Ichhar where she became much sick and feeble and bed-ridden for a long time and that is why the complainant could not give information to the P.S. and after recovery your complainant informed the Hura P.S. as well as the S.P., Purulia but of no good. though all the Accused persons committed serious offences punishable in U/S 498A/34, 326/34, 314/34, 315/34 and 307/34 I.P.Code.

It is, therefore, prayed that your Honour be pleased to send this petition of complaint to the Officer-in-Charge, Hura P.S., Dist. Purulia, for investigation in U/S 156(3) Cr.P. Code for the ends of justice.
