In producing here with 02 (Two) arrested accused persons namely (i) Pradip Kuiry (23) S/O Anadi Kuiry of Vill- Rampur Kabirajdih tola Majhidih, PS- Kotshila, Dist- Purulia (ii) Dinesh Paramanik (25) S/O Madhusudan Paramanik of Vill- Majhidih, PS- Kotshila, Dist- Purulia and seizure the following article; (i) 60 (Sixty) sealed bottles of PHENCYREX Cough Syrup 100 ml. each (Chlorpheniramine Maleate & Codeine Phosphate Syrup) of M & B MAY & BAKER PHARMACEUTICALS Ltd. Company, Batch No.- 24077-SMB1, Exp date- JUN 2019 containing one Carton (ii) 50 (Fifty) sealed bottles of ELTURES-T cough syrup 100 ml. each (Codine Phosphate & Triprolidine Hydrocloride Syrup) of Elder PHARMACEUTICALS Ltd. Company, Batch No.- SD17020 Exp date- APR 20119 containing one Carton (iii) One Maroon colour ALTO Car bearing reg. no. JH09G 6937.

I do here by lodged a written complaint against the above noted accused persons I beg to state that on today(06/09/17) at 15:00 hrs. during my day Mobile duty I received a telephonic information from my source that 02 (two) persons coming from Brajapur side to Jhalda side on Gola- Ihalda Road with huge quantities of drugs by a Car. After received such type of information myself along with force who were performing day mobile duty rushed to Ganta more and keep our vehicle in a safe distance. We wait for few times and at 15:35 hrs we found that the said vehicle coming from Brajapur side to Jhalda side. We intercepted them at Ganta more, and also found that the said vehicle loaded with huge quantities of Syrup by this Car. On being asked they disclosed their identity as noted above. On being searched we found the above noted seized articles. On demand they failed to produce any valid documents/license in respect of keeping and carrying the said drugs, as well as valid documents of this vehicle. Accordingly I seized the same under proper seizure list duly signed by the witnesses as well as the apprehended persons and also prepared label with seal two bottles as sample. I arrested the said accused persons for violating the sec. 27 of drugs & cosmetics Act 1940. On interrogation they admitted their guilt and they also stated that they procured the same fraudulently and sale it at Majhidih and Dimu side under Kotshila P.S. The arrest and seizure was made 16:15 hrs. to 16:45 hrs. with maintaining all formalities of arrest.

I therefore pray before you to start a case against the above noted arrested accused persons under sec. 27 of drugs & cosmetics Act 1940 and arranged for its investigation.
