In producing herewith the two arrested accused persons namely 1. Saminkhan (48) S/o-Lt. Dowadali Khan of Vill-Hossaindih (Kulipara) 2. Sk Murad (35) S/o-Sk Saffi of Vill-Kantadih (Kazikuli), both of PS-Jhalda, Dist-Purulia along with one MAX Pick-Up Vehicle No-WB-55/6645 loaded with five (05) white colour Cows (called as Balad) as per seizure list. I SI Uttam Mondal of Jhalda PS lodged a complaint against the above noted accused persons to the effect that on 06.09.17 at 20:15 Hrs. received a source information from my reliable source that one Pick up van mentioned above was coming from Illo side towards Jhalda having loaded with Cows.

This information communicated to I/C Jhalda PS and noted in G.D vide GDE No-241 Dtd-06.09.17 As per direction of I/C Jhalda PS, I SI Uttam Mondal and force namely 1) Constable-1492, Dilip Gorai 2) Constable-797, Chandi Charan Rajak left PS at 20:25 Hrs. to work out the source information vide Jhalda PS GDE No-242 and C.C No-2712/17 Dtd-06.09.17. We reached at near Saldaha Bridge on Jhalda-Baghmundi Road with my source at about 20:45 Hrs. and watching for the above mentioned Vehicle. After waiting 5/7 minutes, on suspected ground we intercepted a Pick-up van U/S-41 Cr.P.C which was coming from Illo side. On searching we found 05 (Five) white colour Cows (called as Balad) are loaded in the vehicle and was carrying in cruel manner within a short space of the vehicle. I also verified the source information and found that it was correct information about the above mentioned vehicle. I asked them to produce the relevant documents in respect of the Cows (Balad) and as well as live stocks permit but they failed to produce any valid documents in respect of the Cows (Balad) and as well as live stocks permit. During interrogation they also clearly confessed that they as per command and connivance of 1. Sk Jabbar S/o-Sk Nisar Ali of Vill-Kantadih (Upar Para), PS-Jhalda, Dist-Purulia 2. Sk Sabir S/o-Sk Chhutu of Vill-Bagandih, PS-Jhalda, Dist-Purulia habitually deal with the business of stolen Cows (called as Balad) without live stocks permit and assisting in concealment and disposing voluntarily of stolen cows in a clandestine manner since years. I recovered five (5) Cows (called as Balad) from the accused persons and seized the offending MAX Pick-Up Vehicle No-WB-55/6645 loaded with five (5) Cows (called as Balad) after preparing proper seizure list duly signed by accused persons and accompanied Police persons because of unavailability of the local people.

So, I arrested accused 1. Samir Khan (48) S/o-Lt. Dowadali Khan of Vill-Hossaindih (Kulipara) 2. Sk Murad (35) S/o-Sk Saffi of Vill-Kantadih (Kazikuli), both of PS-Jhalda, Dist-Purulia after explaining ground of arrest and observing all formalities regarding arrest and brought to PS along with MAX Pick-Up Vehicle No-WB-55/6645 loaded with five (5) Cows (called as Balad).

Therefore I request that a specific case may kindly be registered against the above noted accused persons 1. SamimKhan (48) S/o-Lt. Dowadali Khan of Vill-Hossaindih (Kulipara) 2. Sk Murad (35) S/o-Sk Saffi of Vill-Kantadih (Kazikuli) 3. Sk Jabbar S/o-Sk Nisar Ali of Vill-Kantadih (Upar Para) 4. Sk Sabir S/o-Sk Chhutu of Vill-Bagandih, all of PS-Jhalda, Dist-Purulia under proper section of law.
