Sir,

In producing here with the following accused Persons namely 1. Ramesh Lal Sonkar @ Khatick (45) S/o-Pagal Sonkar @ Khatick of Vill-Bikash Nagore (Gosala), Jara Basti, PS-Ramgarh, Dist-Ramgarh, Jharkhand 2. Tinku Barma (30) S/o-Lt. Birju Burma of Vill-Bikash Nagore (Gosala), Jara Basti, PS-Ramgarh, Dist-Ramgarh, Jharkhand and seized articles One (01) Auto Bearing Registration No-JH-01P/2885, Two (02) Bhojali (approx length 16" & 12" of each) made of iron with wooden butt, Two (02) Iron rods length of each approx 18" and 30", One(01) bundle Nylon rope length approx 20', Two (02) wine bottle half filled (all seized articles were kept into the back side seat of the Auto except Voialis and Moblile phone) and one Micromax-800 black colour mobile phone having inserted with BSNL SIM bearing No-8987718388 (which was kept in the right side pocket of the full pant of Ramesh Lal Sonkar @ Khatick) as per seizure list. 1 ASI Basudev Acharya of Jhalda PS lodged a complaint against the above noted accused persons to the effect that on 09.09.17 at 22:15 Hrs. received a credible telephonic source information that 06/07 unknown miscreants assembled and prepared themselves near a bridge of Gopalpur road near Meri Apkar Ground under Jhalda Jhalda PS, Dist- Purulia with a view to commit Dacoity in a solvent house around the assembled place. After getting this information I informed I/C Jhalda PS and diarized the information vide Jhalda PS GDE No-362 Dtd-09.09.17 and as per his direction I ASI Basudev Acharya being accompanied with Night mobile officer and force namely ASI Nemai Ch. Nemo, C/797-Chandi Charan Rajak, C/1492-Dilip Gorai and C/399- Kartick Singh Mura left PS by Govt. Hired Vehicle (Marshal) Bearing Registration No-WB-55/6183 to work out the information vide Jhalda PS GDE No-363 Dtd- 09.09.17 and Vide Jhalda PS C.C No-2845/17 Dtd-09.09.17. I along with accompanied Officers and force having kept our vehicle on bifurcated road which is connected to SH-4A, proceeded approx 100 meters towards Meri Apkar ground on foot and when we reached near the place of occurrence at about 23:35 Hrs. having ambushed us as well as guided by our source who was standing on SH-4-A road as per my direction and observed in the moon light and found from 30/40 fit away that 06/07 persons were in drunk condition and were whispering among themselves which was not understandable to us. During the time of their whispering we disclosed our identity as police at about 23:50 Hrs. and warned them not to move. But having got the scent of police party arrival, all the miscreants tried to flee away but due to hard chase, two (02) miscreants were apprehended mentioned above. I interrogated them at the spot and during interrogation they disclosed their identity as noted above. We immediately search their body and found one Micromax-800 black colour mobile phone having inserted with BSNL SIM bearing No-8987718388 (which was kept in the right side pocket of the full pant)on their One (01) Auto Bearing Registration No-JH-01P/2885, Two (02) Iron rods length of each approx 18" and 30", One(01) bundle Nylon rope length approx 20', Two (02) wine bottle half filled (all seized articles were kept into the back side of the Auto) and one Micromax-800 black colour mobile phone having inserted with BSNL SIM bearing No-8987718388 which was kept in the right side pocket of the full pant of Ramesh Lal Sonkar @ Khatick and one Vojali made of iron with wooden butt approx length 16" in the right waist of him, One Vojali made of iron with wooden butt approx length approx length 12" in the right waist of accd Tinku Borma One (01) Auto Bearing Registration No-JH-01P/2885, Two (02) Iron rods length of each approx 18" and 30", One(01) bundle Nylon rope length approx 20', Two (02) wine bottle half filled (all seized articles were kept into the back side seat of the Auto except Vojalis and Mobile Phone) and I seized all the articles after preparing proper seizure list duly signed by the police witnesses as there was no public witnesses found in the dead hours of night and in odd place and as well as accused persons. On further interrogation they disclosed that they were altogether 07 persons including them namely 1. Sk Nizam S/o-Lt. Sk Fazil 2. Sk Kalu @ Kalua S/o-Sk Abul 3. Sk Arshad S/o-Lt. Sk Jinnat, all of Villge Kantadih, PS-Jhalda, Dist-Purulia and two others of which the name were not known to them and all five (05) managed to flee away. On further interrogation they also disclosed that they all assembled there and prepared themselves to commit house dacoity in a solvent family nearby the place of and any any as this area is not known to them but the other

persons came here having hired a Auto car to commit dacoity having met with the local criminals noted above those were known to them. During interrogation arrested accused Ramesh Lal Sonkar @ Khatick (45) S/o-Pagal Sonkar @ Khatick of Vill-Bikash Nagore (Gosala), Jara Basti, PS-Ramgarh, Dist-Ramgarh, Jharkhand confessed that he is involved in Ramgarh PS case No-270/17 Dtd-17.08.17 U/S-457/380/411 IPC and the other arrested Co-accused Tinku Borma always assist him in different crime. They also confessed that they committed crime previously in Jhalda area also.

I ASI Basudeb Acharya of Jhalda PS arrested the above noted two accused persons after preparing Arrest memo and Inspection memo and brought them to P.S. along with seized articles and lodged a complaint against arrested accused Persons namely 1. Ramesh Lal Sonkar @ Khatick (45) S/o-Pagal Sonkar @ Khatick of Vill-Bikash Nagore (Gosala), Jara Basti, PS-Ramgarh, Dist-Ramgarh, Jharkhand 2. Tinku Burma (30) S/o-Lt. Birju Borma of Vill-Bikash Nagore (Gosala), Jara Basti, PS-Ramgarh, Dist-Ramgarh and absconding accused persons namely 3. Sk Nizam S/o-Lt. Sk Fazil 4. Sk Kalu @ Kalua S/o-Sk Abul 5. Sk Arshad S/o-Lt. Sk Jinnat, all of Villge Kantadih, PS-Jhalda, Dist-Purulia and two(02) others unknown.

Therefore I request that a specific case may kindly be registered against the above noted accused persons namely 1. Ramesh Lal Sonkar @ Khatick (45) S/o-Pagal Sonkar @ Khatick of Vill-Bikash Nagore (Gosala), Jara Basti, PS-Ramgarh, Dist-Ramgarh, Jharkhand 2. Tinku Burma (30) S/o-Lt. Birju Burma of Vill-Bikash Nagore (Gosala), Jara Basti, PS-Ramgarh, Dist-Ramgarh and absconding accused persons namely 3. Sk Nizam S/o-Lt. Sk Fazil 4. Sk Kalu @ Kalua S/o-Sk Abul 5. Sk Arshad S/o-Lt. Sk Jinnat, all of Villge Kantadih, PS-Jhalda, Dist-Purulia and two(02) others unknown under proper section of law and arrange to its investigation.
