In producing here with one arrested accd. Person namely Manoj Kr Mondal (38) @ Bombhola S/O-Lt. Abinash Mondal of Vill-Ichag, PS-Jhalda, Dist-Purulia brought under arrest with seized articles 01(One) whit coloured plastic jar cane containing approx 10 (Ten) Ltrs. of I.D. Liquor, 01 (One) Aluminium Pipe, 01 (One) Aluminium Handi big size, approx 10 kg. Molasses, approx 500 gm. yeast and some fire wood from his possession as per seizure list to the effect that on-10.09.2017 at 15:35 Hrs. I received telephonic credible source information that two persons making and selling I.D Liquor at Ichag and Illo village at their own residence respectively. I inform the matter to I/C Jhalda P.S over Phone and as per his direction diarized the matter Vide Jhalda PS GDE No-393 Dtd-10.09.17 and myself along with ASI Basudeb Acharyee J.C/693- Nitai Mondal, J.C/765- Sahadeb Rana left PS for Ichag and Illo villages to work out the information Vide Jhalda PS GDE No-394 Dtd-10.09.17 and Vide C.C No- 2850/ 17 Dtd-10.09.17. We reached at Ichag Village at about 18:15 Hours and held raid in the house of Monoj Kr Mondal (38) @ Bombhola S/O-Lt. Abinash Mondal of Vill-Ichag, PS-Jhalda, Dist-Purulia and found that the accused person making and selling I.D liquor in his premises accordingly I seized 01(One) whit coloured plastic jar cane containing approx 10 (Ten) Ltrs. of LD. Liquor, 01 (One) Aluminium Pipe, 01 (One) Aluminium Handi big size, approx 10 kg. Molasses, approx 500 gm. yeast and some fire wood under proper seizure list duly signed by the local and police witnesses as well as accused person with proper label after having packaging all those.

On integration he confessed that he used to make noxious I.D liquor for drinking and selling purpose having adulterated by various noxious things and he also confessed that this I.D liquor could be dangerous for human life even caused death to human life. On demand he could not produce any valid documents in favour of making and selling the same. He also confessed that he has connivance of such things with Nitya Mondal S/o-Lt. Panu Mondal of Vill-Illo, PS-Jhalda, Dist-Purulia and Nitya Mondal also used to supply noxious I.D liquor to him as when required or as per his demand. Accordingly I arrested accused Manoj Kr Mondal (38) @ Bombhola S/O-Lt. Abinash Mondal of Vill-Ichag, PS-Jhalda, Dist-Purulia having maintained all formalities after issuing arrest memo

We also held raid in the house of Nitya Mondal S/o-Lt. Panu Mondal of Vill-Illo, PS-Jhalda, Dist-Purulia but he was not found home. Foul smell of ID liquor was waving in his house and one big chulli (Unun) with fire wood are present. Even huge quantity of ID liquor poured on earth and was flowing like water.

Therefore I request that a specific case may kindly be registered against the above noted accused persons namely 1. Manoj Kr Mondal (38) @ Bombhola S/O-Lt. Abinash Mondal of Vill-Ichag, PS-Jhalda, Dist-Purulia 2. Nitya Mondal S/o-Lt. Panu Mondal of Vill-Illo, PS-Jhalda, Dist-Purulia under proper section of law and arrange to its investigation.
