- 1) That, the petitioner is the permanent resident of Village-Kantadih, Post-Jhalda, P.S.-Jhalda, District-Purulia, West Bengal and within the jurisdiction of this Ld. Court at Purulia.
- 2) That, on 13/08/2017 some quarrel taken place in between the petitioner and his wife namely Amiran Bibi, over the said issue his wife went at her father's house and made complaint against the petitioner to her father and her brothers.
- 3) That, after some time at about 13.30 hours the father-in-law of the petitioner Babu Kaji and his three sons namely Rafique Kaji, Azad Kaji and Imran Kaji came to his home and started to assault him with lathi, bhujali and rod, all the above noted persons started to assault him on his parts of the body and Rafique Kaji and his two brothers namely Azad Kaji and Imran Kaji assaulted him on his head by rod, as a result he was grievously injured and he was fall down and became senseless.
- 4) That, the petitioner was hospitalized at Jhalda B.P.H.C at Jhalda and for better treatment he was referred at Deben Mahato Sadar hospital at Purulia and he is submitting the treatment documents with the petition.
- 5) That, the above noted all persons assaulted on his head with an intention to kill him.
- 6) That, there is every possibilities that all the accused persons may kill him in future as they came to know that he is alive.
- 7) That, he was also visited Jhalda police station but the police refused to accept his written F.I.R.
- 8) That, the petitioner made a written complaint before the S.P at Purulia but no any action took place till date.
