

- 5) That, the above noted all persons assaulted on his head with an intention to kill him.
- 6) That, there is every possibilities that all the accused persons may kill him in future as they came to know that he is alive.
- 7) That, he was also visited Jhalda police station but the police refused to accept his written F.I.R.
- 8) That, the petitioner made a written complaint before the S.P at Purulia but no any action took place till date.







It is therefore prayed that your Honour may graciously be pleased to send this petition to the Jhalda P.S after treating this as F.I.R and further be pleased to pass an order directing the Jhalda P.S. to do investigation of the case after lodging F.I.R against the accused persons.
