Date of Occurance:- On 29.7.2017 at about 8.00 A.M.

The above named petitioner; beg to state as follows;

1. That the complainant cultivate the land since the settlement by the landlord in favour of the father of the petitioner
2. That this years also the petitioner kept paddy seed in the land being R.S. Khatian No. 14, ^{R.S. Khatian no-11} R.S. Plot No. 45 of mouza Alkusha area 1.39 Acres Kanali.
3. That all the accused persons on 29.7.17 at about 8 a.m. forcibly and illegally entered into the land of the complainant with deadly weapon such as lathi, tangi, ballam and plough and damage paddy seeds of the complainant. Hearing this the complainant raised objection but they threatened to kill the complainant by sawing tangi but any how complainant managed to escape from the spot with the help of witnesses. The accused persons damaged the entire paddy seeds of the complainant. So the complainant sustained loss of Rs.3000/-. The complainant raised ^{objection} against the illegal activities of the accused persons then all the accused persons became angry and thing started to assault the complainant by fist and blows.
4. That the matter was informed to the local Joypur P.S. but police did not take any action till now. Thereafter the matter was also inform to the S.P. Purulia but no good.
5. That the complainant sustain a loss of Rs.3000/- for the illegal activities of the accused persons.
