Sir,

In producing here with the accused person namely SK Mafijuddin @ Alu Bharta (40) S/o-Late SK Amir of Kantadih, PS-Jhalda, Dist-Purulia brought under arrest along with seized articles as per seizure list i.e. one improvised country made one shooter pipe gun length approx 10 inches having Iron butt, body, barrel, trigger, firing pin etc and one round live ammunition, I, ASI Tarun Bhui of Joypur PS do hereby lodged a written complaint against the above noted accused person to the effect that on 22/09/17 at 23:35 hrs, duty officer of Joypur PS, ASI Susanta Ghosh received a secret source information that one person was moving on Joypur Pundag pitch road near Sashi more, Joypur PS in suspicious manner. After receiving such information duty officers ASI Susanta Ghosh noted the fact in GD vide Joypur PS GDE No-988 dated 22/09/17 and after discussion with IC Joypur PS inform me over telephone while myself along with force C/-102 Jogindar Singh, C/-753 Shyamsundar Mahato & HG/-438 Gopal Mahato were performing anti-crime night mobile duty near Joypur Railway Xing More vide Joypur PS CC No-3073/17 dated 22/09/17. After receiving such information I contacted with IC of the PS over phone and as per his kind direction, myself along with force rushed to the spot to work out the said information and on 23/09/2017 at 00:15 hrs we reached near to Sashi more and keeping our Govt. Vehicle No- WB 11TE - 3866 in a safe distance we slowly moved to the information place and found said person was standing under a tree nearby for any crime upon the ongoing vehicle on Joypur-Pundag pitch road at any time and we able to apprehended him and on being suspicion I search the said person and found that one improvised country made one shooter pipe gun loaded with one round live cartridge was kept in his left side of the waist under is full pant. On demand of papers he failed to produce any papers / documents in support of carrying / possessing such fire arms. On interrogation he disclosed his identity as noted above and made incoherent statement in respect of his presence at that place and also the purpose of possessing said fire arms and ammunition. It is reasonable to believe he choose the said along place pre-plainly to commit any grievous offence against vehicle etc. So finding no any other alternative way and after observing all the formalities I seized the said fire arms and ammunition under a proper seizure list in presence of witnesses as well as accused person and make over one copy of the seizure list to him and he put his signature as token of acknowledgement and also labeled the same by me. I tried my label best to singed the public witnesses but as time is dead in night and in alone place and far distance from villages so none present there, So I unable to put signature any public witnesses on the seizure list. Hence I arrested him issuing memo of arrest as he is liable for prosecution u/s 25 (1) (a) Arms Act.

I therefore pray that a specific case may kindly be started against the accused person namely SK Mafijuddin @ Alu Bharta (40) S/o-Late SK Amir of Kantadih, PS-Jhalda, Dist-Purulia, under proper section of law and arrange its regular investigation.
