Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Dasarath Karmakar, S/O LT. Sripati Karmakar, Vill.-Kashipur, PO- P.K. Raj, Dist-PURULIA has committed theft of Electricity U/S-135(1)(a)(b) of the Electricity Act 2003,(Amendment) Act-2007.

On dated 21.09.2017 I received a secret complain over telephone that Sri Dasarath Karmakar, S/O LT. Sripati Karmakar, Vill.-Kashipur, PO- P.K. Raj, Dist-PURULIA consuming electricity by means of taping from service cable before entering the meter of WBSEDCL. Meter No B2882551, make Bentec Electrical and Electronics Pvt Ltd. with FR 2382.

On the basis of said complaint at about 12.40 pm. I, Sri MrinalChowdhury, Assistant Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL along with,

- 1) Sri Dipak Kr. Bhowmik, SAE, Kashipur CCC
- 3) Sri Sanjoy Garain, OE Kashipur CCC.

Entered the premises of Sri Dasarath Karmakar, and found that he is consuming electricity dishonestly by means of taping by with bypassing meter for registering actual consumption against consumer id 242058930.

Total Load found approx 0.9 KW (PUMP-1, fan-8 no, TV-1 no, CFL-5 no)

Then we disconnect his permanent connection and seized the following articles.

- 1) Energy Meter - Meter No B2882551 make Bentec Electrical and Electronics Pvt Ltd with FR 2382.

After preparation of proper seizure list The seizure list are prepared at the site and the representative of accused person refuse to sign in the seizer list. The inspection team left the above premises at about 01.05 pm. The accused person has committed an offence U/S-135(i)(a)(b) of the Electricity (Amendment) Act-2007 for illegal-theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
