Respected Sir,

In producing herewith arrested accused namely Gobinda Kr Sahu (19) S/O - Lt Uday Sahu of village Ludri PS - Chanho, Dist - Ranchi, Jharkhand along with seized articles, I beg to report that on 28.09.17 in course of mobile duty myself along with force got reliable source information that one person is selling country liquor at Jorapukur village, Kashipur near Hari Mandir. Accordingly myself along with C/237 Gopinath Roy and C/580 Pradip Kr Bag both of Kashipur P.S reached at near Hari Mandir Jorapukur at about 16.25 hrs and found that one person was selling C.S. liquor beside the road. After seeing police party liquor customers fled away from the spot. On demand the seller failed to produce any valid document for selling C.S. liquor in his possession. So the above noted accused has committed an offence U/S - 46(A)(c) B.E. Act 1909 Amended up-to date. During search I found (1) 18 (Eighteen) sealed bottles of DILKHUSH C.S. liquor (600 ml each) (2) 05 (Five) empty bottles of DILKHUSH C.S. (3) 05 (Five) Plastic Tea Glass (4) Rs.110/- (One hundred Ten) as sale proceed seized the above noted articles under proper seizure list duly signed by the witnesses in between 16.35 hrs to 16.55 hrs. I also seized and labeled bottles with sample C.S. liquor at the spot in presence of accused person and witnesses. Accordingly I arrested the above noted accused person U/S - 67 Bengal Excise Act 1909 and informing him the ground of arrest and I prepared arrest memo after maintaining all arresting rule as well as I brought him to P.S. with seized above noted articles.


