Respected Sir,

In producing herewith arrested accused namely Tarani Mandal (52) S/O - Lt Surendra Mandal of village Bhabanipur PS - Kashipur Dist Purulia along with seized articles, I beg to report that on 28.09.17 in course of mobile duty myself along with force got reliable source information that one person namely Tarani Mandal (52) S/O - Lt Surendra Mandal of village Bhabanipur PS - Kashipur Dist Purulia is selling country liquor at Bhabanipur village, Kashipur in his house. Accordingly myself along with C/589 Srinibas Mahato and NVF/1061 Mahadeb Mahato both of Kashipur P.S reached in the house of Tarani Mandal (52) S/O - Lt Surendra Mandal of village Bhabanipur PS - Kashipur Dist Purulia at about 19.45 hrs and found that one person was selling C.S. liquor beside the road. After seeing police party liquor customers fled away from the spot. On demand the seller failed to produce any valid document for selling C.S. liquor in his possession. So the above noted accused has committed an offence U/S -46(A)(c) B.E. Act 1909 Amended up-to date. During search I found (1) 14 (Fourteen) sealed bottles of DILKHUSH C.S. liquor (600 ml each) (2) 04 (Four) empty bottles of DILKHUSH C.S. (3) 06 (Six) Plastic Tea Glass (4) Rs.120/- (One hundred Twenty) as sale proceed seized the above noted articles under proper seizure list duly signed by the witnesses in between 19.55 hrs to 20.15 hrs. I also seized and labeled bottles with sample C.S. liquor at the spot in presence of accused person and witnesses. Accordingly I arrested the above noted accused person U/S - 67 Bengal Excise Act 1909 and informing him the ground of arrest and I prepared arrest memo after maintaining all arresting rule as well as I brought him to P.S. with seized above noted articles.

Therefore I pray before you that kindly arrange to start a specific case under proper section of law U/S 46(A) (c) B.E. Act 1909 against arrested accused Tarani Mandal (52) S/O - Lt Surendra Mandal of village Bhabanipur PS - Kashipur Dist Purulia and arrange for its investigation.
