In producing herewith accused Mathur @Arjun Sahis (35 Yrs) S/O Tarani Sahis, of vill-Belamu, P.S. – Kotshila Dist – Purulia with seizure of 4 (four) liters illicit spirit containing one Jarican, One used big size handi, 08 Kg (Approx) mahua, one used 10 liters plastic empty Jarican, one polithine pipe length about 01 meter, I.D Liquor containing in a plastic Jarican approx 10 Ltrs. all are used and possession of materials for manufacturing and selling of spirit which was seized under proper seizure list with label.

I beg to submit that today (21.09.17) in between 13.25 hrs to 14.05 hrs a raid was conducted in the house of Mathur@ Arjun Sahis (35 Yrs) S/O Tarani Sahis, of Belamu, P.S. – Kotshila Dist – Purulia. On acting a secret source information against for unlawful manufacture of spirit and selling of intoxicating drug use and possession of materials for manufacture of spirit and intoxicating drug, which were manufacturing in the house Premises of accd person. On demand he failed to produced any valid documentary authority in respect of selling and manufacturing of illicit spirit which in kept in Jarican approx 4 liters, One used big size handi, one used empty 10 liters Jarican, 08 Kg. (Approx) mahua, one polithine pipe length about 01 meter, I.D Liquor containing in a plastic Jarican approx 10 Liters from the possession of accd person. Which was seized under proper seizure list which enclosed here with. During arrest the ground of arrest were duly notified issuing arrest memo u/s 50 Cr.P.C. and handed a copy of the same to arrestee.

The above noted arrested accd namely (1) Mathur@ Arjun Sahis (35 Yrs) S/O Tarani Sahis, of Belamu, P.S. – Kotshila Dist – Purulia. Committed offence u/s- 18 (i) B.E. Act. For possession of intoxicating not obtained from a licensed vendor and in contravention. It may note here that during raid (01) RM 2425 Bhusan Pradhan, (02) RM 2584 Pranesh Pradhan accompanied me.

Under the fact and circumsances I therefore pray a case u/s 46A (c) (d) B.E. Act. 1909 may kindly be started against Mathur@ Arjun Sahis (35 Yrs) S/O Tarani Sahis, of Belamu, P.S. – Kotshila Dist – Purulia.
