

The above name complainant begs to state as follows:

- That the complainant as well as the accused person are the permanent resident of village & P.O. Jharbagda, P.S. Manbazar, Dist-Purulia.
- 2) That prior to the incident there was some quarrel in between the complainant and the accused persons with regard to some landed properties. Which is situated at mouza Jharbagda, under P.S. Manbazar, recorded as J.L. No. 193, R.S. khatian no. 22.
- That in such circumstances the complainant and other have to file one Title Suit bearing no. 257/2017 before the Ld. Civil Judge Jr. Division Purulia and another application under order 39 rule 1 & 2 of C.P. Code also filed against the accused persons and the Ld. court has been pleased to pass necessary order of injunction restraining the accused persons from entering in to the plot and to interfere with the peaceful possession of the complainant and other.
- 4) That the complainant after passing such order served notice upon the accused persons and after receiving such notice the accused persons became very much annoyed as they were then trying to take action against the complainant and others.





- That on the date of incident i.e. on 23/06/2017 corresponding 5) to 8th Ashar 1424 B.S. at about 11:00 AM when the complainant and other were supervising the cultivation work when the another were ploughing the land for paddy transplantation at that time all the above noted accused person all on a sudden armed with lathi etc., criminally trespassed in to the lands with a view to dispossess the complainant, thereafter abused the complainant and his men with filthy languages, then the complainant protested such illegal act of the accused persons resisting hot altercation. In such circumstances the accused persons pushed and pulled the complainant assaulted him with lathi causing minor / pain injuries over all his body and also assaulted his right leg with the help of lathi. The accused persons also damaged the paddy seed lings which were kept by the complainant in a portion of the land causing loss of Rs. 12,000/- (Approximately)
- That when the incident was out of controlled and when the complainant afraid of his life and property then there was hue and cry and neighboring cultivator collected there then the accused persons left the place after taking away the plough and other instruments of cultivation the value of those articles are about Rs. 20,000/-.
- 7) That while the incident so happened the result of common intention of the accused persons.





- 8) That the accused persons also threatened the complainant by giving out that if the complainant dare to inform the incident to any other including the P.S. in that case they would take revenge.
- 9) Tat the land exclusive belonged to the complainant and his cosharers and under the physical possession of them. Contrary to that the accused persons have no manner of right or possession over therein.
- 10) That the complainant thereafter lodged one complaint to the local P.S. in writing and when no legal action was taken by the said Police then another complaint was lodged to the Superintendent of Police Purulia but same fate. Hence the complainant is under compelling circumstance filed this complaint before this Ld. Court under the law.

In the circumstances it is therefore, prayed that your honour may be pleased to send the petition of complaint to the Officer-in-charge, Manbazar P.S. treating the same as FIR under section 156(3) for investigation.
