I, SI Basudev Samanta, in producing herewith two arrested accused namely 1) Bibek Paswan (22) S/O- Rajesh Paswan of Sitalpur 3 no, PS-Kulti, Dist- Paschim Bardhaman and 2) Pradip Yadav (25) S/O - Naresh Yadav of Sitalpur Chotto Dhemo More, PS-Kulti, Dist- Paschim Bardhaman with one White color Apache motor cycle bearing registration No- WB 44D/6973 along with one improvised pipe gun approx 31.5 cm in length consisting wooden butt, barrel, trigger, firing pin, hammer etc. along with 02 round live cartridge to the effect that today on 23/09/17 at 21:05 hrs received a telephonic information before duty officer that one White color Apache motor cycle bearing registration No- WB 44D/6973 along with driver and pillow rider with arms coming from Dishergarh side towards Raghunathpur with a ill motive for committing any serious crime. Accordingly duty officer diarised the matter vide Neturia PS GDE No- 1023 dated: 23/09/17 and informed to O/C Neturia PS accordingly, as per kind order of O/C Neturia PS myself along with ASI Purnendu Chandra, C/841 Chanchal Paramanik, C/373 Abani Bhushan Mahato & C/230 Asish Kr. Mahadani who ware engaged in raid duty left for Dishergarh side to work out the information. We reached at Parbelia 3 no more on Purulia - Barakar road at 21:45 hrs and started Naka there. Subsequently the said vehicle found coming from Dishergarh side and while reached at Parbelia 3 no more, we showed signal to stop the vehicle but they tried to flee away but after hot chasing them managed to stop the motor cycle and also cordoned the motor cycle and found the driver and the pillow rider were seated in the motor cycle. Then we commended them to surrender, on that time they did not pay any heed and also further tried to run away. We succeeded in rounding up the vehicle along with above noted accused persons. On being asked they disclosed their identity as noted above. Accordingly we searched the above noted persons very carefully and also searched the motor cycle and recovered one improvised pipe gun approx 31.5 cm in length consisting wooden butt, barrel, trigger, firing pin, hammer etc. along with 02 round live cartridge which were concealed under the seat of the above noted motor cycle. On demand the valid documents in respect of arms & ammunition as well as of vehicle but they did not say any satisfactory accounts and unable to produce any documents in respect of arms as well as the vehicle. Then i seized and labeled one improvised pipe gun along with 02 round live cartridge and also seized vehicle bearing registration No- WB 44D/6973 from their possession under proper seizure list duly signed by the accused person and witnesses between 00:15 hrs to 00:35 hrs. on 23/09/17. I arrested both the accused persons and issued arrest memo after maintaining all formalities of arresting rule. On interrogation they confessed their guilt and stated that they were going to Raghunathpur side with a view to commit serious crime. During seizure, I have tried to procure public witnesses to put down signature but none turned out.

Under such circumstance it is reasonably believe that arrested accused person and others have committed a serious offence and they are liable to offence U/S- 25/27 & 35 arms act.

Therefore, I pray that a specific case may kindly be registered against 1) Bibek Paswan (22) S/O- Rajesh Paswan of Sitalpur 3 no, PS-Kulti, Dist- Paschim Bardhaman and 2) Pradip Yadav (25) S/O - Naresh Yadav of Sitalpur Chotto Dhemo More, PS-Kulti, Dist- Paschim Bardhaman under proper section of law.
