In Producing herewith the arrested accused namely (i) Bijoy Rajak (22Y) S/O Kailash Rajak of Parbelia, PS- Neturia, Dist-Purulia, ii) Raju Pandey (38Y) S/O Pravash Pandey of vill- Neturia, PS- Nerturia, Dist- Purulia, iii) Ranjit Tantubai (40Y) S/O Lt. Durgadas Tantubai of Madhukunda, PS- Santuri, Dist- Purulia, iv) Abdul Siddiqui (49Y) S/O *bdul Gaffar of vill- Bheti, PS- Santuri, Dist- Purulia, v) Sk. Amjad (30Y) S/O Sk. Ajijul of vill- Murulia, PS- Santuri, Dist- Purulia, vi) Guddu Singh (40Y) S/O Rabi Singh of **Darbelia coalliery, PS- Neturia, Dist- Purulia, vii) Anil Agarwal (40Y) S/O Om Prakash Agarwal of vill- Saltore, PS- Neturia, Dist- Purulia and seized articles i) cash Rs.262926/- (Rs. 2000X90,500 X138, Rs.100X111, Rs. 50X51, Rs. 20X 3, Rs. 10X 20, Rs. 5X3 & Rupee 1X1) ii) playing cards -05 sets, iii) One satranji upon which the accused persons were seating on course of playing gambling.

I beg to state that I SI Nervai Chandra Patra of Neturia PS do hereby lodged complaint against the above persons to the effect that on 01.09.17 at 22.05 hrs. ASI Purnendu Chandra who was on table duty received an information that one Sri Hareram Singh along with his manager had arranged a gambling on one of the ground floor rooms of Madhuban Marriage hall at Parbelia New colony under PS-Neturia. ASI Purnendu Chandra noted the information on PS GDE book vide Neturia PS GDE No- 41 dated- 01.09.17 and informed you about the information received. You enrasted me to work out the information.

As per your direction myself along with 1. ASI Deb Kumar Chattaraj, ASI Abu Akher, C-9323 Samiran Dey, C- 1304 Dhananjoy Mondal, C- 269 Lakhindar Tudu, JC- 702 Pratap Narayan Das all of Neturia PS left PS at 22.15 hrs for Parbelia to work out the information vide Neturia PS GDE No- 42 dated- 01.09.17 and CC No- 2601/17 dated- 01.09.17, with Govt. vehicles bearing Regd. No WB56C/8993. At 22.20 hrs. we reached at Parbelia bazaar and kept the vehicle there and approached towards the marriage hall on foot and at 22.30 hrs. we reached in front of said marriage hall and tried to surround the marriage hall and found that about 10/15 persons are playing cards or. exchange of money in right side hall of the ground floor of Madhuban Marriage Hall with the help of tube light. The owner Hareram Singh and his manager were also physically present. We also noticed that the huge amount of oney & 5 sets of playing cards is lying on the gambling board.

By this time the assembled persons somehow got the presence of police and some of them including Hareram Singh and his manager were also managed to escape taking the advantage of comparatively lesser manpower. However we apprehended 07(Seven) persons. Being asked they disclosed their identity as noted a love. I seized and labeled the following articles from the board of gambling under proper seizure list.

Mad his no charge on chicer in-charge on station police Station

- i) Cash Total Ps.262926/- (Rs. 2000X90 ,500 X138 ,Rs.100X111, Rs. 50X51, Rs. 20X 3, Rs. 10X 20, Rs. 5X3 & Rupee 1X1)
- ii) Playing card: 05 sets.
- iii) One satranji upon which the accused persons were seating on course of playing gambling.

The arrested accused persons and others were causing wrongful gain for someone and wrongful loss to others at a same time by way of playing cards sitting in a room. Hareram Sing & his manager allowed the arrested persons and others to do the same by sitting in a room on his marriage Hall without any Constitutional authenticity. As such the arrested persons and Hareram Sing and his manager and others are liable for prosecution U/S-3/4 W.B G & P. C. Act, 1957.

Therefore after producing the arrested accused & seized article I pray before your good self, a specific case may kindly be initiated against (i) Bijoy Rajak (22Y) S/O Kailash Rajak of Parbelia, PS- Neturia, Dist-Purulia, ii) Raju Pandey (38Y) S/O Pravash Pandey of vill- Neturia, PS- Nerturia, Dist- Purulia, iii) Ranjit Tantubai(40Y) S/O Lt. Durgadas Tantubai, of Madhukunda, PS- Santuri, Dist- Purulia, iv) Abdul Siddiqui (49Y) S/O Abdul Gaffar of vill- Bheti, PS- santuri, Dist- Purulia, v) Sk. Amiad(30Y) S/O Sk. Ajijul of vill- Murulia, PS- Santuri, Dist- Purulia, vi) Guddu Singh(40Y) S/O Rabi Singh of Parbelia colliery, PS- Neturia, Dist- Purulia, vii) Anil Agarwal(40Y) S/O Om Prakash Agarwal of vill- Saltore, PS- Neturia, Dist- Purulia and viii) Hareram Singh & his Manager under proper section of law.
