Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. Person namely Paritosh @ Raja Bauri (34) S/O Dugai Bauri of village Bora, PS-Neturia, District- Purulia with seizure of (1) 20 pc. Sealed bottles of **Captain** country spirit containing 600 ml each, (2) 15 pcs. Sealed bottles of **Dil Khush** country spirit containing 375 ml each which were seized under proper seizure list.

I beg to submit that today (12.09.17) in between 19.05 hrs to 20.45 hrs. a raid was conducted in Goomty Shop of Paritosh @ Raja Bauri (34) S/O Dugai Bauri of village Bora, PS-Neturia, District- Purulia situated at Sarbari bazar beside Sarbari Bankura pitch road under PS Neturia on acting of a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling liquor which were kept in his Goomty on demand Paritosh @ Raja Bauri failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents . As such he committed offence u/s 46 A(c) of B.E. Act and he was arrested U/S-67 BE Act and also (1) 20 pc. Sealed bottles of **Captain** country spirit containing 600 ml each, (2) 15 pcs. Sealed bottles of **Dil Khush** country spirit containing 375 ml each which were seized under proper seizure list duly signed by witnesses and labeled at the time of arrest. During arrest the ground of arrest was duly notified issuing arrest memo u/s 50 Cr.P.C. and handed a copy of the same to arrestee.

The arrested accd. namely Paritosh @ Raja Bauri (34) S/O Dugai Bauri of village Bora, PS-Neturia, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid I. C /141 Subhash Ch. Kaibarta, 2. C/ 1192 Raicharan Maji & 3. C/ 207 Dilip Kr. Paul all of Neturia PS accompanied me.

Under the fact and circumstances I therefore pray that a specific case may kindly be started against Paritosh @ Raja Bauri (34) S/O Dugai Bauri of village Bora, PS-Neturia, District- Purulia under proper section of law.
