




Date, mime and place of occurrence:

On 04/09/2016 at about 12 non followed by a number of occassions including 23/09/2017, 30/07/2017, intervening night of 03/08/2017 and 04/08/2017 and till today. Offences committed under Sections :-


341/363/365/506/120B I.P.C. read with sections 10 & 11 of prohibition of Child Marriage Act, 2006.

The humble petition on behalf of the above named petitioner/ complainant, Most respectfully sheweth :-

- 1) That one Intaj Ansary is the complainant's xhon to son who is aged about 16 years being his date of birth 2 = /03 /2 001.
- 2) That one Serajuddin Ansary who is the Co-villager of the complainant has got a minor daughter namely Margis Khatoon.



- other a friendly relationship had grown up between them i.e. in between said Intaj and Margis.
- 4) That on 04/09/2016 at about 12 noon said Intaj and wargis being triends to each other were gossiping in the house of said serajuddin.
- That taking advantage of their such solitude discourse said serajuddin along with his wife motivatedly went out of his house and called some dignatories of their community including his brothers Jahangir Ansary, Muslim Ansary and Nasir Ansary Sons of late worken Ansary one Asiruddin Ansary s/o. Mukshed Ansary and wife of Asiruddin viz. Jainab Bibi and others of village Dubra P.S. Para- and District Purulia and when they assembled there and saw said Intaj Ansary and Margis Khatoon Were gossiping your petitioner was called for and when he along with his wife had been to there at the residence of said serajuddin Ansary the persons assembled pronounced their verdict by saying that said Intaj would have to be given in marriage with said wargis Whatoon, but your petitioner most humbly his refusal to such proposal and requested them to remember the fact that both of them were minors and their marriage, such an age would certainly be in utter violation of Law.



That then those persons decided that the marriage of said Intaj and Margis would be solemnised after their attaining majority and a date was fixed and the same is 12/07/2019 and the complainant again uttered that still said Intaj would not attain the required age of marriage i.e. 21 and the persons behind would be quilty and would come within the penal provisions of the prohibition of Child marriage Act, 2006 and in consequence of such a disclosure the persons gather d with said serajuddin Ansary took partitioned view and told that the complainant would like to evade the proposed marriage by trickery and they held out threat by saying that if the complainant or his relations took recourse of law/Acts/ penal code, then they would remove them from this world. That apart they procured the signature of your petitioner on a blank formate o of " Mikanama " forcibly so that your petitioner or his relati one would not be able to disown the event of the proposed

That there after the above named accused persons marriage. INCOM in connivance with each other without the knowledge and consent of your petitioner or his relations took Intaj Ansary with them on 23/09/2016 near the vacant

place in front of the house of Isaak packary s/o. Rahim Ansary of Village Dubra P.S. Fara, and District Purulia and gave him in marriage with the minor daughter of Serajuddin Ansary i.e. with wargis Khatoon and unfortunately the "Nika wama" so mentioned in the forgoing paragraph was utilized in the very event in utter violation of law of the

That after performance of such illegal activities the accused persons forcefully caused arrangement for entrance of said Margis into the house of your petitioner asked him to maintain said Margis, though they also had ensured him that he would not be made compelled to allow Intaj to remain with said Margis as husband and wife but the cost of her day to day life would have to be borne by your petitioner till 12/07/2019, thereafter both Margis and Intaj would have to start to pave their life as husband and wife and in case of refusal the complainant would have to suffer rigorous imprisionment since the accused persons held out threats by saving that on refusal they would implicate your petitioner and his relatives in different false Criminal cases even the complainant's minor son would not also be spared and your petitioner out of fear was reluctantly compelled to accept the entry of said wargis Khatoon into



their residence, but after a great deal of toil succeeded to keep those minors separately.


- bouse of your retitioner who maintained her as his own daughter, but suddenly one night she placed her obstinate sulkiness by way of saying that she would spend the nights to come with said Intaj Ansary to which your petitioner and his other inmates declined and on the following morning said wargis out of her own volition left the residence of the complainant and went away to her father's house.

 Thereafter for a considerable period neither Margis Came again to your petitioner's house, nor did her parents keep any relation with or take any information about your petitioner or his inmates till 29/07/2017.
 - 10) That however last on 30/07/2017 the accused person no. = 1 i.e. said Serajuddin Ansary, happensto be the father of wardis had talks with your petitioner's son Intaj over mobile phone and asked him to take back Nargis to his father's house and to maintain her there as earlier till 12/07/2019 and on good faith he had been to his residence in the evening hours but alas did not return till today.

-7 - SUDICIAL MENTAL SUIT

said Serajuddin for time and again but the accused No.-1 remained silent over the issue and last on 04/08/2017 on inquiry the accused no.-1 abused your petitioner, threatened him with dire consequences and finally replied your petitioner "Toder Chheleke ar fire Pabina, oke Whalas Mare diyechhi.".

petitioner was informed that on interening night of 03/08/2017 and 04/08/2017 the above named accused persons by a " B O L L E R O " four wheelers took him to uppardih, P.O.— Ray Bandh P.S.— wituria, and District Purulia. But till today he failed to have any specific where abouts of his son Intaj and he and his relatives thus reasonably apprehending the foreboding of thunder—crash and he on 06/08/2017 after sun set with the apprehension of utter ruin rushed to para P.S. and lodged an information there with in writing inter alia depicting all the reality so taken place but the police personnel of mara P.S. did not take any positive steps against the wrong doers by starting any specific case till 10/03/2017 and as a secuel where of your petitioner finding no



alternative intimated the matter in writing to the superintendent of Police, Purulia on the following day i.e. on 11/08/2017 but that too has failed to evoke any response from the end of the Police administration.

13) That, the fact of the case highly warrants Folice investigation and more over your petitioner being an indigent person is unable to bear the day to day expenses of the case.

It is, therefore, prayed that your Honour may graciously pleased to forward the instant petition of complaint to the officer-in-charge, Para P.S.-U/s.- 156(3) Cr.p.c. with a direction upon him to cause investigation into the case by a competent police officer not below the rank of an S.I. sonsidering the gravity of the offence.
