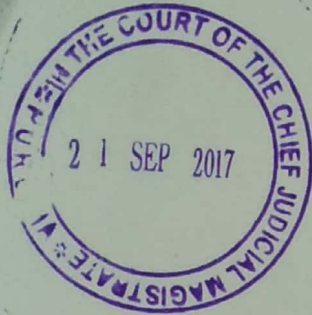

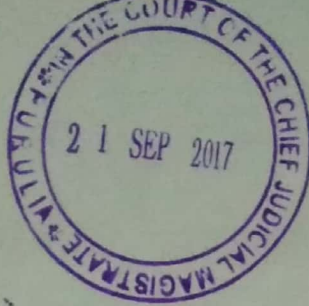

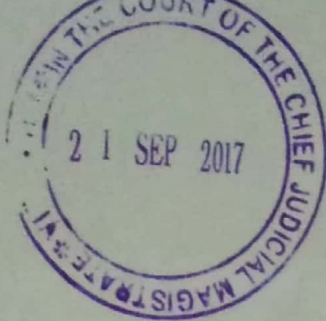

The Complainant above named begs to state as follows :-

1. That the father of the Complainant namely Anil Rajwar is the rightful owner and possessor of the land described in the Schedule below and he purchased the land from the rightful owner of the land namely Jhagru Rajwar by a Registered sale deed dated 18.6.2002. After purchase the Complainant and his father came into

possession over the same by raising surrounding boundary walls with the help of bricks. Thereafter the Complainant has been possessing the same by growing g vegetables and other Rabi crops therein.

2. That the accused persons have got no right, title, interest and possession over the land described in schedule below.

3. That on the date of occurrence, i.e. on 30.8.2017 at about 7 P.M. all the accused persons named above being armed with Lathi, Sabal, Gaiti in their hands by forming an unlawful assembly with an intention to commit theft forcibly and ~~inter-~~ illegally started to break the bricks boundary walls of the complainant with the help of sabal and Gaiti and they damaged and broken down the boundary walls of the Complainant. The Complainant sustained loss of Rs.4,000/- . The Complainant raised objection against the illegal activities of the accused persons but all the accused persons started to assault the complainant by fists and blows .

Thereafter all the accused persons took away about one thousand bricks from the land of the Complainant.

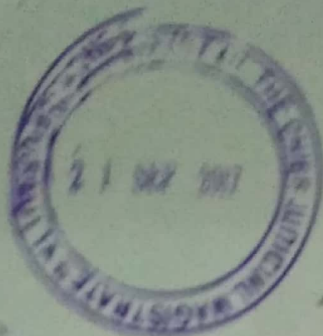
complainant. The value of the said stolen bricks is about Rs.6,000/- . The said stolen bricks are still lying in the Khamar/^{bari}of the accused persons.

4. That the complainant reported the matter to the Officer-in-charge, Purulia (M) P.S. but Police did not take any steps against the accused persons due to Political pressure. The Complainant also reported the matter of the Superintendent of Police Purulia on 4.9.2017 but till now Police did not take any action against the accused persons. The Accused persons are still now threatening to the Complainant in a dire consequences.

5. That the Complainant is a poor man and there is a question of search and seizure. So for the ends of justice the Police case is required.

It is, therefore, prayed that your Honour may be graciously pleased to send this petition of complaint to the Officer-in-charge, Purulia (M) P.S. treating the same as F.I.R. and to investigate the same as provided Under Section 156(3) Cr.P.C. accordingly.
