In producing herewith one arrested accd. person namely Sarbeswar Mahato (45 yrs) s/o Birbal Mahato of Vill-Jambaid, PS-Purulia (M), District - Purulia with seizure list and seized

I beg to submit that today (24.09.17) during mobile duty, acting of a secret source information and as per order of O/C Purulia (M) PS myself along with force had been to village Jambaid under PS Purulia (M) at 18:35 hrs. and as per indication conducted raid in the house of Sarbeswar Mahato (45 yrs) s/o Birbal Mahato of Vill-Jambaid, PS- Purulia (M), District -Purulia at 18.55 hrs. and found 2/3 persons fled way from his house and detained one person on asking his identity he disclosed his name address as noted above. On interrogation he confessed his guilty for selling and possession of country spirit styled a 'DILSE'. On demand he failed to produce any valid document in respect of selling of said country spirit at his house. As such I seized 20 bottles of Country Spirit styled as DILSE each Bottle contains 600 ml, 05 empty bottles of DILSE and Empty plastic glass 03 pcs ,01 bottles taken from 20 bottles as sample under proper seizure list in presence of witnesses and signed by witnesses and accused person. Arrested the above noted accused person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labeled in presence of witnesses duly signed by them and accused person.

The above noted arrested accd. namely Sarbeswar Mahato (45 yrs) s/o Birbal Mahato of Vill-Jambaid, PS-Purulia (M), District - Purulia committed offence u/s 46 A ( c ) B.E.Act. 1909, for unauthorized possession and sales of country spirit (DILSE) at his house.

Under the fact and circumstance kindly take necessary lawful action against Sarbeswar Mahato (45 yrs) s/o Birbal Mahato of Vill-Jambaid, PS- Purulia (M), District - Purulia.
