Sir,

In producing herewith one arrested accd. person namely Ranjit Gorain(31) S/O Sri Bablu Gorain of Bhabanipur, P.O Hutmura, P.S Purulia(M), Dist. Purulia with seizure list and seized articles.

I beg to submit that today (25.09.17) during mobile duty, acting of a secret source information and as per order of O/C Purulia (M) PS myself along with force had been to village Bhabanipur under PS Purulia (M) at 16:05 hrs. and as per indication conducted raid in the house of Ranjit Gorain (31) S/O Sri Bablu Gorain of Bhabanipur, P.O Hutmura, P.S Purulia(M), Dist. Purulia at 16.35 hrs and found 2/3 persons fled way from his house and detained one person on asking his identity he disclosed his name address as noted above .On interrogation he confessed his guilty for selling and possession of country spirit styled a DILSE. On demand he failed to produce any valid document in respect of selling of said country spirit at his house. As such I seized 36(thirty six) bottles of Country Spirit styled as DILSE each bottle contains 600 ml, 06 empty bottles of DILSE and Empty plastic glass 05 pcs ,01 bottles taken from 36 bottles as sample under proper seizure list in presence of witnesses and signed by witnesses and accused person accordingly. Arrested the above noted accused person after informing him the ground of arrest, observing all legal formalities regarding arrest. The seized articles were properly sealed and labeled in presence of witnesses duly signed by them and accused person.

The above noted arrested accd. Ranjit Gorain(31) S/O Sri Bablu Gorain of Bhabanipur, P.O Hutmura, P.S Purulia(M), Dist. Purulia committed offence u/s 46 A (c) B.E.Act. 1909 for unauthorized possession and sales of country spirit (DILSE) at his house.

Under the fact and circumstance kindly take necessary lawful action against Ranjit Gorain(31) S/O Sri Bablu Gorain of Bhabanipur, P.O Hutmura, P.S Purulia(M), Dist. Purulia.
