Sir,

In producing herewith one arrested acced. person namely Bharat Bouri (67 yrs) s/o Lt Guhiram Bouri of Vill-Chayanpur , PS- Purulia (M), District - Purulia with seizure list and seized articles .

I beg to submit that today (13.09.17) acting of a secret source information as per order of O/C Purulia (M) PS myself along with force had been to village Chayanpur under PS Purulia (M) at 18.45 hrs and as per indication conducted raid in the house of Bharat Bouri s/o Lt Guhiram Bouri of Vill-Chayanpur PS- Purulia (M), District - Purulia at 18.55 hrs and found 2/3 persons fled way from his house and detained one person on asking his identity he disclosed his name address as noted above .On interrogation he confessed his guilty for selling and possession of country spirit styled a DILSE. On demand he failed to produce any valid document in respect of selling of said country spirit at his house. As such I seized 45 bottles of Country Spirit styled as DILSE each Bottle contains 600 ml, 12 empty bottles of DILSE and Empty plastic glass 09 pcs ,02 bottles taken from 45 bottles as sample , 3 (three)1/2 bottles drinking water , one black colour polithin sheet under proper seizure list in presence of witnesses and signed by witnesses and accused person. Arrested the above noted accused person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labeled in presence of witnesses duly signed by them and accused person.

The above noted arrested acced. Namely Bharat Bouri s/o Lt Guhiram Bouri of Vill-Chayanpur PS- Purulia (M), District - Purulia committed offence u/s 46 A (c) B.E.Act. 1909 for unauthorized possession and sales of country spirit (DILSE) at his house.

Under the fact and circumstance kindly take necessary lawful action against Bharat Bouri s/o Lt Guhiram Bouri of Vill-Chayanpur PS- Purulia (M), District - Purulia
