1 SI Debasis Bandyopadhyay, O/C Purulia (M) PS do hereby lodged complaint as suo-motu against 05(five) arrested accused persons namely (1) Dwijapada Bhuiya (55) S/O Late Sadai Bhuiya (2) Shibu Mahato(56) S/O Late Bhikhu Mahato (3) Ajoy Bhuiya (20) S/O Jagadish Bhuiya (4) Pashupati Bhuiya (21) S/O Dwijapada Bhuiya (5) Smt. Mousumi Bhuiya (24) W/O Shaktipada Bhuiya all of village Chakda, P.S Purulia(M), Dist. Purulia to the fact that today i.e, on 02.09.17 at 10:20 hrs. received an information that some villagers of Chakda village were constructing house on Chakda GORU BATHAN which is vacant land of Swarupananda Ashram, Chakda and were also cutting drain on the village path illegally and forcefully. This refers to Purulia(M) P.S G.D.E No.73 dtd. 02/09/17. Accordingly the mobile duty officer ASI Biswajit Banerjee and force were asked to attend the same. Considering the gravity of the incident I also asked SI Lakshmikanta Pati and force to assist ASI Biswajit Banerjee. He was also performing patrolling duty. After a while receive the information over mobile phone from S.I L.K. Pati that local villagers became furious and were showing agitation against Police. They were also using filthy languages and tried to hackle Police. I have informed the matter to my superiors and as per instruction myself alongwith officers & force including Lady constables rushed to the spot at 11:35 hrs. We tried to convince regarding law in respect of land matters. There was a mob more than 100 persons at the spot. The mob was in very agitated mood. Somehow at about 12:55 hrs we could be able to convinced them but suddenly the mob became violent and tried to damage the Govt. vehicle and started pelting stone/ bricks bat upon the Police party. We tried to pacify the mob by convincing the matter but the mob became so much violent and started pelting stone, brickbats aiming the Govt. vehicle and aiming towards Police. As a result on duty P.D

Asoke Singh and ASI Biswajit Banerjee received injury on their person. Finding no other alternative I called re-enforcement from Police Lines. I also informed the matter to the superior officers and requested for re-enforcement. To save our life and property declared them as un-lawful assembly and we chased the mob to disperse. When the mob fled away some local people were also injured due to brick-batting. However we could be able to apprehend 05(five) persons who disclosed their name and address as noted above. The above noted persons were also found leading line of the agitated mob. On 02.09.17 at 13:15hrs. to 13:45 hrs. the persons were arrested observing all legal formalities regarding arrest. Brickbats, stones, lathi, rod etc. were seized from the possession of the accused personal from the P.O. from the possession of the accd. persons brick bats, stone, iron rod, lathi etc were recovered and seized under seizure list between 13: 55 hrs. to 14:55 hrs. in presence of witnesses and accd. persons. We tried to search for local witnesses but none was willing to put signature on the seizure list. The injured police persons were medically treated at Purulia Sadar Hospital.

As such for committing offence punishable U/S-147/148/149/353/186/323/325/506/ 332 IPC. started Purulia (M) PS case No-227/17 Dtd-02.09.17 U/S-147/148/149/353/186/323/325/506/332 IPC against accd persons (1) Dwijapada Bhuiya (55) S/O Late Sadai Bhuia (2) Shibu Mahato(56) S/O Late Bhikhu Mahato (3) Ajoy Bhuiya (20) S/O Jagadish Bhuiya (4) Pashupati Bhuiya (21) S/O Dwijapada Bhuiya (5) Smt.
