I do hereby lodge my complaint empowered by the Electricity(Amendment) Act-2007 to the effect that Ranjit Hazra S/O Satya Narayan Hazra of Vill - Chharra, PS-Purulia(M) has committed theft of electricity under section 135(1)(b) as detailed here under.

Today, i.e. on 11.09.2017 I, Prashant Kishor (AE&SM), along with Sri Chinmoy Maity,SAE(E), & Debdulal Banerjee, Sr.TSH of Telkalpara CCC, WBSEDCL conducted a raid programme at village Chharra under Purulia(M) P.S. When our team at about 01.30 P.M. entered to the Domestic premises of Ranjit Hazra, we found that he was enjoying electricity dishonestly by means of Meter bypass by way of tampering incoming of meter and run Domestic appliances, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, tampered Meter with service cable dismantled and seized and seizure list prepared .The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 02.00 P.M.after completion of inspection & necessary formalities.

Ranjit Hazra S/O Satya Narayan Hazra of Vill -Chharra, PS-Purulia(M) has committed theft of electricity under section 135(1)(b) of the Electricity(Amendment) Act-2007.
