Sir,

In producing herewith one arrested accd. person namely Kshirode Kumar Mahato (36 yrs) s/o Lt Arjun Mahato of Vill-Gopalpur, PS- Purulia (M), District - Purulia with seizure list and seized articles as per seizure list.

I beg to submit that today (14.09.17) acting of a secret source information myself along with force conducted raid at 19.05 hrs in the pan stall of Kshirode Kumar Mahato s/o Lt Arjun Mahato of Vill-Gopalpur, PS- Purulia (M), District - Purulia at Gopalpur more and found that the above noted person was selling country spirit styled a DILSE at his pan stall. On demand he failed to produce any valid document in respect of selling of said country spirit at his stall. As such I seized 35 bottles of Country Spirit styled as DILSE each Bottle contains 600 ml, 04 (four) empty bottles of DILSE and Empty plastic glass 06 pcs, one black colour polithin sheet, one bottle taken as sample out of 35 bottles under proper seizure list duly signed by witnesses and accused person and also arrested the above noted accused person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labeled in presence of witnesses duly signed by them and accused person.

The above noted arrested accd. namely Kshirode Kumar Mahato (36 yrs) s/o Lt Arjun Mahato of Vill-Gopalpur PS- Purulia (M), District - Purulia committed offence u/s 46 A (c) B.E.Act. 1909 for unauthorized possession and sales of country spirit (DILSE) at his house.

Under the fact and circumstance I therefore pray that kindly take necessary lawful action against namely Kshirode Kumar Mahato (36 yrs) s/o Lt Arjun Mahato of Vill-Gopalpur, PS- Purulia (M), District - Purulia.
