Sir,

In producing herewith one arrested accd. person namely Lalit Rajwar (36 yrs) s/o Pairag Rajwar of Vill-Choto Chanchra, PS- Purulia (M), District – Purulia with seized articles 20 bottles of Country Spirit styled as DILSE each Bottle contains 600 ml, 10 empty bottles of DILSE and Empty plastic glass 05 pcs. with seizure list.

I beg to submit that today (10.09.17) during PS area mobile duty, acting of a secret source information at 15:05 hrs and I along with force conducted raid at 15:45 hrs in the house of Lalit Rajwar (36 yrs) s/o Pairag Rajwar of Vill-Choto Chanchra, PS- Purulia (M), District – Purulia and found that the above noted person was selling country spirit styled a DILSE at his house. On demand he failed to produce any valid document in respect of selling of said country spirit at his house. As such I seized 20 bottles of Country Spirit styled as DILSE each Bottle contains 600 ml, 10 empty bottles of DILSE and Empty plastic glass 05 pcs under proper seizure list in presence of witnesses duly signed by witnesses and accused person and also arrested the above noted accused person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labeled in presence of witnesses duly signed by them and accused person.

The above noted arrested accd. namely Lalit Rajwar (36 yrs) s/o Pairag Rajwar of Vill-Choto Chanchra, PS- Purulia (M), District – Purulia committed offence u/s 46 A (c) B.E.Act. 1909 for unauthorized possession and sale of country spirit (DILSE) at his house.

Under the fact and circumstance I therefore pray a case u/s 46 A (c) B.E.Act. 1909 may kindly be started against Lalit Rajwar (36 yrs) s/o Pairag Rajwar of Vill-Choto Chanchra, PS- Purulia (M), District – Purulia and arrange for its investigation.
