Sir,

In producing herewith (1) Saroj Mahanty (55 yrs) s/o Lt Amiya Mahanty & (2) Soumitra Mahanty s/o Saroj Mahanty both of Nadiha Misti Mahal, PS- Purulia (T), Dist- Purulia. I, SI-Dipak Kr Nandi of Purulia Traffic Unit do here by lodge complaint that, today (27.09.2017) at about 17:45 hrs, while myself along with (1) JC/518, Rajkumar Pathak, (2) NVF- Rohin Kr Mahato, (3) NVF- Nimai Singh Mura of Traffic Unit, Purulia, were performing traffic duty in proper uniform (vide Traffic Purulia CC No 12/17 dated 26.09.17) at Dulmi - Ketka morh on NH 32 to control vehicular traffic in view of huge gathering due to Durgapuja - 2017, that time above accused persons along with one unknown person keeping their four wheeler about 100 mtr away, came to me and asked me to let their vehicle enter on that road disobeying temporary no-entry. I asked them to take the bypass road informing about huge crowd on that road and the fact of temporary no-entry that road. But those persons did not heed any attention to my word and abused me with filthy languages and asked me to let them go on that road, otherwise they will apply force. I again stated them about the fact of no-entry and requested to take another road, but all of a sudden, they attacked me and started physical assault by fist & blow and thus deterred me to discharge lawful Govt duty. My accompanying force tried to pacify them, but they were continuing criminal force upon me. Finding no alternative, I informed my superiors and with the help of my accompanying force, managed to detain above persons when another one fled away. During scuffling, said Soumitra Mahanty fell on the ground and got injury on his finger. As those persons were conducting cognizable offence and applied criminal force upon a police personnel who was in proper uniform and was discharging Govt duty, so I arrested them at 18:10 hrs with all legal formalities and took in to my custody and bring them to Purulia (I) PS with the help of my accompanying force, keeping O/C, Traffic Purulia in my duty place who came there later. I asked both the accused persons to meet a doctor, but he denied.

Therefore, I pray that, considering the above fact, necessary legal action may be taken against above accused persons.
