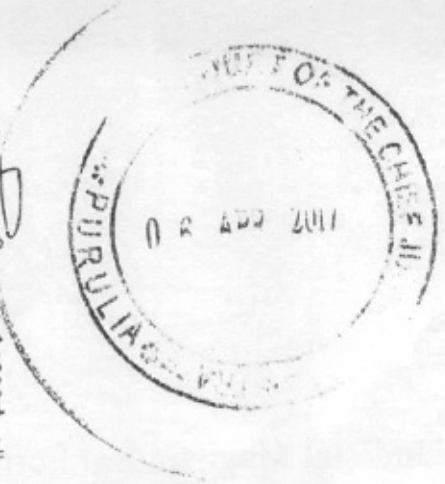

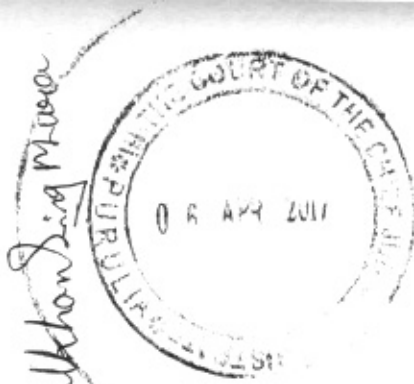
The humble petition on behalf of the Complainant

beg to state as follows :-

Most Respectfully sheweth

1. That your complainant is the permanent resident of Village and P. O Birgram, P. S Baghmundih, Dist Purulia, under the jurisdiction of the Ld. Court.
2. That on 18.05.16 all the accused person as mentioned above posed themselves as the accused no. 1 is the founder and chairman of Rastriya Janakalyan Udyog, accused No. 2. Is the Secretary of Rastriya Janakalyan Udyog, and the accused No. 3 and 4 are the In Charge of the said organization having the office at 1st floor of Ganesh Sweet, Dulmi Down of Purulia District.
3. That the said organization announced that they would provide various jobs within Purulia District and the date for interview was fixed on 16.07.2015 and your complainant and some other persons appeared before the interview Board at Purulia then all the accused persons on being satisfied issued appointment letter to the various persons including your complainant.
4. That your complainant was posted as Co-Ordinator at Baghmundih and the Chairman i.e the accused no. 3 took Rs. 60000/- from your complainant on condition that your complainant would receive a monthly salary of Rs. 8500/- i. e on each and every calendar month.

5. That your complainant attended the office regularly for 6 months without any salary and on several occasion your complainant approached the accused persons and requested them to make payment of that salary but the accused persons gave assurance to them for their payment.
6. That on 8.12.2016 your complainant went to the District office at Purulia but saw that the office was under lock and key and all the accused persons fled away and in this way your complainant and other persons visited the office but same they was seen and it is learnt that the entire episode was fake and vague.
7. That in this way all the accused persons after making conspiracy with each other cheated your complainant and there was wrongful loss to your complainant and wrongful gain to the accused persons.
8. That your complainant on several times went to the Head Office at Calcutta but it was also found under lock and key.
9. That police investigation is required in the aforesaid incident where so many persons including your complainant have been cheated by the organization in the name of providing jobs after receiving huge amount form them.
10. That your complainant informed the matter to the local P. S and the S. P Purulia but of no good.

It is therefore prayed that your honour may be pleased to send this petition of complainant to the Purulia (T) P. S Purulia for investigation in U/ s 156(3) Cr. P. C for the end of justice.
