before my son was beaten up by a teacher in school  
and I had complained to the Principal against this.  
But <sup>from</sup> then on my son is subjected to mental torture  
in the school by the teachers. He is being targeted  
and all this is going on with the encouragement of the  
Principal. Today while the exam was going on my son  
was isolated from other kids of his class and brought  
down to 1st floor and thrashed and harassed by the  
teachers. When I asked the staff why it was done  
so the principal started abusing me and accused  
my son of being naughty in the class. Not only this  
they used insulting words against me and I was physi-  
cally assaulted by the guards of the school.

I therefore request you to kindly take  
strong action against the principal of the school and  
do the necessary as early as possible.
