In producing herewith accused Saharab @ Baddu Ansary (23 yrs.) S/o Lt Khalil Ansary of Kulti, Ranitola (Sabji Market), PS - Kulti, Dist - West Burdwan with one improvised country made Pipe gun and one round of live ammunition, I ASI Sujoy Kr. Pati beg to state that in course of evening mobile duty, special drive, I received a source information at about 20:35 hrs through my cell phone that one person with his motorcycle was waiting near Gopinathpur village More on Raghunathpur - Purulia pitch road approx 1 KM away from Sanka Rly Gate towards Anara Side. His movement was very much suspicious in nature.

Receiving such information, I informed O/C over phone and as per direction of O/C myself along with force i.e. C/79 Shaktipada Shaw, C/457 Prasanta Mondal vide C.C. No. 3523/17 dtd 24.09.17 left Adra more near Raghunathpur New Bus Stand at about 20:45 hrs with Bolero Vehicle bearing No WB 55A/2214 for Gopinathpur more. We reached there and as per identification of my source myself along with officer and force got down from the vehicle at about 21:05 hrs. Seeing us, the above accused attempted to run away with the motorcycle but could not succeed. I got hold of his hand and other two accompanied force cordoned him. After detaining him I asked him about his details, purpose of staying there. Firstly he was not revealing the truth but later on repeated question, he revealed his identity as noted above. I informed him that he would be searched by us and offered him to search our person before our search. Finding no other option, he brought out of his back side of waist from inside the back portion of his pant (1) 01 (one) improvised country made Pipe gun having length as 26 CM approx diagonally from the end point of butt to that of the barrel, length of wooden butt being 7 CM approx, barrel 14.5 CM approx, having trigger and firing pin, and also brought out from left pocket of his pant (2) 01 (one) round of 8 mm live ammunition. On demand he was unable to produce any valid documents /license in respect of keeping such arms & ammunition, neither he can gave any satisfactory explanation in respect of carrying such arms ammunition. It appeared he possessed those either to sell or to commit any crime. So I seized the said arms and ammunition along with the motorcycle he used to come from Kulti, make - Hero Honda Glamour, red & black in colour, bearing Reg. No. WB 38V/9242 with proper seizure list and the seized arms and ammunition packed, sealed and leveled in presence of police witnesses since none found there available to witness the seizure in between 21:35 hrs and 22:15 hrs. Hence I arrested him at about 22:25 hrs as he has committed an offence which is punishable U/S - 25/27 of Arms Act.

Hence I pray to start specific case against accused Saharab @ Baddu Ansary (23 yrs.) S/o Lt Khalil Ansary of Kulti, Ranitola (Sabji Market), PS - Kulti, Dist - West Burdwan u/s Arms Act.
